## 2020-2021 School Year

### Immunization Requirements for Students in Kindergarten, Grades 1, 2, 3, 4, & 5

**Important:** On 6/13/19, NYS eliminated the religious exemption from vaccinations for school attendance.

Dear Parent/Guardian,

New York State Law Section 2164 requires certain immunizations (shots) to enter kindergarten and attend school. Please check with your health care provider as soon as possible to make sure that your child has all the needed immunizations.

### Required Immunizations for Kindergarten & Grade 1, 2, 3, 4, & 5

Immunization	Number of Doses
Polio	<b>4 doses</b> or <b>3 doses</b> if the 3rd dose given at 4 years of age or older
Hepatitis B	<b>3 doses</b>
Diphtheria/Tetanus/Pertussis	<b>5 doses</b> or <b>4 doses</b> if the 4th dose given at 4 years of age or older or 3 doses if 7 years or older & series started at age 1 or older
Measles/Mumps/Rubella	<b>2 doses</b>
Varicella (Chickenpox)	<b>2 doses</b>
<b>MEDICAL EXEMPTIONS</b>	<b>UPDATED ANNUALLY</b> within 14 days from the <b>first day school</b>

Proof of immunization should be sent to the school nurse

- **EXCLUSION DATE is 14 days from the 1st day of school**

Proof of immunization must be **any 1 of the 3** items listed below:

- An immunization certificate signed by your healthcare provider
- Immunization Registry report (NYSIS or CIR from NYC) from your healthcare provider or your county health department
- A blood test (titer) lab report that proves your child is immune to the diseases
  - For varicella (chickenpox), a note from your healthcare provider (MD, NP, PA) which says your child had the disease is also acceptable.
