## The Registration Process

### 1. REGISTER ONLINE

An on-line registration MUST be completed before an email will be sent with instructions on how to proceed. Visit our website at <https://www.fairfieldschools.org/parents/student-registration> to start this process.

### 2. CURRENT REGISTRATION PROCESS DUE TO COVID VIRUS

Due to the current state of the world, we have changed our registration process (for the time being) while safely working remotely. Once your on-line registration has been completed, we will send you an email (that will include our email addresses) to request documentation to have your son/daughter enrolled in the upcoming 2020-21 school year. We prefer all documents be in a PDF format, but will accept picture format if necessary. Once we have returned to the office all registrations will need to take place in person.

#### **Documentation Required to Complete the Registration Process:**

*Your child's enrollment is conditional upon a physical review of their original birth certificate/passport upon our return to Central Office.*

- Student Identification: Official United States, or translated, long form birth certificate is required. If not available, the student's Passport will be required.
- Proof of Residency: mortgage statement OR deed to property OR current lease agreement (*original signed and executed by all parties*)
- Proof of Residency: **Two** current utility bills showing mailing address (original) (*cell phone bills are not accepted*)
- Parent Identification (each of the following is required):
  - Official Current and Non-expired Photo ID (CT Driver's license, State issued ID card, Passport)  
*An automobile insurance card with a Fairfield address is also required if the photo ID does not contain a Fairfield address.*
  - Automobile registration
- If applicable, legal guardianship document(s).*
