# MARK ENVELOPE "FUEL DIESEL BID"

<u>SEALED BIDS MUST BE RECEIVED IN OUR OFFICE BY THURSDAY, JUNE 4, 2020</u> <u>AT 10:00 A.M.</u> when they will be publicly opened and the contents announced. They will be held without right of withdrawal until June 16, 2020 when it is anticipated the Board of Education will be acting on the bid.

Please type or print on the attached bid form, your lowest net price, f.o.b., Palos Heights, for items specified exclusive of taxes. Only those taxes that are applicable to Illinois public schools may be added.

The signature on the Bid Form certifies that bidder has read, understands and agrees that acceptance by the board of education of the bidder's offer (by issuing a purchase order or other document) will create a binding contract together with the specifications and other documentary forms and regulations herewith made a part of this specific procurement or contract. The successful bidder shall not let, assign or transfer the contract or any interest therein without the written consent of the board of education.

#### <u>INTENT</u>

It is the intent of Palos School District 118 to accept and execute any bid in a competitive and equal manner. Therefore, we have elected to use a "price adjustment factor" as a vehicle for determining low-bidder. It is further the intent that this bid be in full compliance with all E.P.A., Federal, State, County, and local codes, in addition to any mandates as set forth by the State and Local Fire Marshall governing Underground Storage Tanks.

The board of education reserves the right to accept or reject any part of or all bids for any reason. The board further reserves the right to determine "equal to" and to accept any alternate bids it deems in the best interest of the school district and to award/assign contract in accordance with industry standards. Any bids submitted unsealed, unsigned or subsequent to the opening date and hour will be disqualified and returned to bidder. Prices quoted in the proposal shall be guaranteed for a period of thirty (30) days after the scheduled time of bid opening.

#### EQUAL EMPLOYMENT OPPORTUNITY CLAUSE

By accepting a contract with the school district, the bidder agrees to abide by all provisions of the Equal Employment Opportunity Clause required by the "Illinois Human Rights Act" as if stated herein in its entirety.

#### HOLD HARMLESS CLAUSE

The contractor agrees to indemnify and hold the school district and its employees harmless from any claims, causes of action, or liabilities for personal injury, property damage, or otherwise arising out of the work performed or the products delivered under this contract.

#### PRODUCT

Blended ultra low diesel fuel (50% mixture of type #1 and type #2) to be used during the 2020/2021 school year.

#### <u>QUANTITY</u>

Approximately 30,000 gallons blended ultra low diesel fuel - storage tank capacity, 6,000 gallons. (Will use a 50% mixture of type #1 and type #2).

#### DELIVERY

Deliveries to be made to the fuel storage tank at the bus storage area, 7710 West McCarthy (127<sup>th</sup> Street), Palos Heights, phone 708.761.5872. Each delivery to be based on approximately 5,000 gallons.

THE VEHICLE USED FOR DELIVERY OF THE ULTRA LOW DIESEL FUEL MUST BE SOLELY FOR THE PURPOSE OF DELIVERING THE SPECIFIED FUEL.

Delivery must be made no later than the second business day after placing the initial telephone order. The initial acceptance and inspection of any delivery shall not be considered as a waiver of any provisions of these specifications and shall not relieve the contractor of its obligations to supply ultra low diesel fuel which meets these specifications.

# **INVOICES**

To be forwarded to the Transportation Office at 7710 West McCarthy, Palos Heights, IL 60463, with copies of signed delivery tickets. Invoices received before the first Tuesday of the month following delivery and acceptance will be processed for board approval and payment that month. Invoices received after the first Tuesday of the month will be processed for payment the following month.

The total amount billed School District 118 shall be the sum of the total gallons pumped times the total price per gallon. Total price per gallon shall be the sum of (a), (b) and (c) below:

(a) The low posted price per gallon, of the type of fuel delivered, as published for Chicago in the Oil Price Information Service (O.P.I.S.). A copy of this <u>must</u> accompany the invoice. This price must be reflected as a specification.

(b) The amount bid as the "price adjustment factor", which is the number of cents per gallon that reflects the profit and overhead of the successful vendor.

(c) Taxes which School District 118 is subject to must be reflected as a specific item in the bills for delivered fuel. NOTE: Tax exempt numbers are Federal 36-84-0080F and Illinois E9997-7400-02.

Successful bidder shall supply Palos School District 118 with material safety data sheets for all products which the school district elects to purchase. These sheets (which are not on file with the district) must precede the delivery of any goods.

#### ADDITIVE REQUIREMENT:

Lubricity enchancer, non-alcohol based, ValvTech diesel guard, or equivalent.

#### VOLUME MEASURE

In all transactions of which this specification is a part, a gallon is defined as a volume of 231 cubic inches at a standard temperature of sixty (60) degrees Fahrenheit (temperature correction is required).

# TEST AND REJECTIONS

All quality control will be under the jurisdiction of the purchasing agent. Palos School District 118 reserves the right to sample deliveries in any manner which will produce samples for testing purposes fully representing the oil delivered.

Ultra low diesel fuel that does not meet the specification requirements will be rejected and when so ordered by the purchasing agent. The contractor shall, at his expense, replace all inferior oil delivered with oil meeting specification requirements. Replaced material must be delivered within the delivery date specified. Should the contractor so elect, he may have a representative present at the time measurements are made and also when tests are run on samples.

When applicable the vendor and/or contractor shall assume all responsibility and expense for obtaining any and all permits (fee or non-fee) and shall pay all taxes required in complying with city, local, county, or state laws, codes or ordinances. This shall be in effect on this contract, purchase order and labor requirements between the vendor/contractor and Palos School District 118.

Any damage to Palos School District 118 properties done during delivery and filling by the contractor shall be immediately corrected, at the contractor's expense.

Normal delivery and filling working hours shall be forty (40) hours, Monday thru Friday, 8:00 a.m. to 4:00 p.m., excluding federal holidays. All deliveries shall be performed during normal work hours.

# ADDENDA

No verbal or telephone inquiries regarding the bid instructions or the award of the bid will be accepted by the school district. If interested bidders have a question regarding the bidding instructions, they may communicate that question in writing to Justin Veihman, Chief School Business Official.
