

# A Message from Our Superintendent, Timothy Terranova



This week marks the beginning of my fourth month as Superintendent of the Victor Central School District (VCSD) and I continue to be amazed at the caliber of students and staff that we have in our community!

As we continue to navigate the challenges of the COVID-19 crisis, our District also faces a challenging budget situation.

Specifically, our District has experienced tremendous growth over the past 15 years and funding has not kept pace with this growth. Our District ranks in the bottom quartile of school districts in New York State for State Aid (funding) received. This has led Victor to have the lowest per pupil expenditure of any school district in New York State as referenced by NY State Comptroller data, along with the lowest tax rate of any district of comparable size in the area.

Lack of funding has impacted staffing ratios throughout the District. For example, VCSD spends the least amount of money on instructional staffing as compared to Rochester area schools with more than 1500 students. VCSD is also significantly understaffed in mental health support, safety and security, curriculum, cleaning and maintenance, and technology. These shortages have become further evident in the midst of the COVID-19 crisis.

Despite the impact of our revenue shortage on our staffing, our District is widely considered to be one of the best school districts in the state. This is, no doubt, a tribute to our students, staff and community, but going forward, it will take much more than tenacity to maintain this exemplary status. In order for our District to continue on a path of success, it is critically important that we examine ways to increase revenue to maintain the excellence for which the District is known.

To that end, our Board of Education has adopted a budget that exceeds the tax cap for the 2020-21 school year.

The specific amounts are detailed in this budget newsletter. Three important points:

- 1. The proposed budget to budget increase is less than the previous year's increase.
- 2. We are only adding a small number of positions in special education, English Language Learners (ELL) and high school counseling. The vast majority of the override is to keep existing positions and to not dip into our already critically low savings.
- Even after this tax cap override, we anticipate
  the Victor Central School District will continue to have the lowest per pupil expenditure
  and the lowest tax rate of any school district of
  similar size in the area.

As a District, we deeply value the importance of being good stewards of taxpayer dollars. This is not a decision which we take lightly, especially with the knowledge that many of you are suffering from the impacts of COVID-19. If we do not exceed the tax cap, we will be forced to make more than \$3 million in reductions, impacting secondary course offerings, art and music at the elementary level, enrichment experiences, class sizes, athletic opportunities, co-curricular experiences and possibly pre-school. This will drastically change the way we educate our children in our District.

I encourage you to review the information in this newsletter and ask questions. Knowledge is power, and the more informed our community is the better. The Board-approved budget will be put in front of VCS voters with mail in ballots due by 5 p.m. on Tuesday, June 9, 2020. Budget passage will require a supermajority approval of 60% or more.

# **VCS Proud Points**

The 2019-2020 school year may have been cut short, but VCS students and staff didn't disappoint with numerous academic, athletic, music and arts achievements. Just a few more reasons we are VCS proud!

- In June, 2019, 98% of our students graduated with a Regents Diploma, 66% percent earned a Regents Diploma with Advanced Designation.
- This past October, the Victor Central School District was ranked 17th in academics out of 431 upstate New York school districts in 48 counties by Buffalo Business First magazine.
- In its 2020 rankings the U.S News and World Report ranked Victor Senior High School the 80th best school in New York State out of 1342 high schools in NY State (top 6%) and the 873rd best school nationally out of 17,792 public high schools nationwide (top 5%). Locally, VSH was ranked 5th out of 75 high schools (top 7%).

# Budget Facts

#### Fact

Expressed as a percentage, the budget increase proposed for 20-21 is actually LOWER than the budget increase from 18-19 to 19-20.

#### Fact

The state's unfunded foundation aid obligation for the 20-21 school year is \$8.9 million dollars per the foundation aid formula.

#### Fact

In the 20-21 proposal, 74.8% of the District's budget is devoted to educational programming

## **Budget Proposition**

Adoption of this budget requires a tax levy increase of 9.34% which exceeds the statutory tax levy increase limit of 1.96% for this school fiscal year and therefore exceeds the state tax cap and must be approved by sixty percent of the qualified voters present and voting.

Shall the Board of Education of the Victor Central School District be authorized to expend \$78,256,890 during the school year 2020-2021 and to levy the necessary tax therefor?

# School Bus Proposition

- (a) That the Board of Education of the Victor Central School District, in the Counties of Ontario, Monroe and Wayne, New York (the "District"), is hereby authorized to purchase various school buses and vehicles for use by the District, and to expend \$865,000 therefor;
- (b) that a tax is hereby voted in the aggregate amount of not to exceed \$865,000 to pay such cost, said tax to levied and collected in installments in such years and in such amounts as shall be determined by said Board of Education; be and
- (c) that in anticipation of said tax, bonds of the District are hereby authorized to be issued in the principal amount of not to exceed \$865,000 and a tax is hereby voted to pay the interest on said bonds as the same shall become due and payable.

# Victor Farmington Library Funding Proposition

Shall the Victor Central School District, Ontario County, New York, be authorized to levy taxes in the amount of \$734,973, separate and distinct from the School District's tax levy for the annual support of the Victor Farmington Library, Victor, New York, and pay over such monies to the trustees of the Victor Farmington Library for library services for the benefit of residents during the 2021 fiscal year and each year thereafter?





Should the 2020-21 budget be defeated and a contingent budget be adopted, the District will reduce operating costs by increasing class sizes district-wide, eliminating extra-curricular clubs, reducing athletic teams, and eliminating some non-mandatory instructional program offerings, Universal Pre-Kindergarten offerings, and instructional leadership. Additionally, equipment purchases must be eliminated and community groups will be required to pay for all costs associated with the use of buildings. (This statement is made pursuant to Section 2023 of NYS Education Law.)

The NYS School Tax Assessment Relief (STAR) program provides qualified homeowners with a \$30,000 assessment reduction for tax purposes. Senior citizens receive a \$69,800 exemption.

# Message From the Victor Farmington Library

The Victor Farmington Library announces that residents in the Victor Central School District can vote on an approximately three cent tax increase per \$1,000 in assessed property value proposal to the library's yearly tax funding, effective for the 2021 calendar year. Ballots will be mailed to eligible residents with the school district's mail-in ballots and must be returned in the pre-paid envelope by June 9.

The proposal amounts to an estimated increase from \$22.00 to \$25.00 per \$100,000 of assessed value on properties in the Victor Central School District. For a home assessed at \$300,000, the tax bill to support the library would be an additional \$9.00 a year or \$0.75 a month. The requested increase would be used to offset the rising costs of library materials and yearly increases in NYS minimum wage, and continue to explore associated costs of a new library for the community.

The Victor and Farmington communities relied heavily on the library throughout 2020, with over 121,000 visitors, 194,051 items circulated, and total program attendance of 13,489 for 994 programs. The meeting rooms were used over 400 times by the public in addition to regularly scheduled library events. Daily attendance in 2020 before the pandemic was over 400 people a day.

# Nine Residents Seek to Fill Three Board Seats

On June 9, 2020, nine community members will seek to fill three seats on the Victor Board of Education. Two of the seats represent the term expirations of those seats held by Board President, Debbie Palumbo-Sanders and Board Vice President, Christopher Parks. Parks will seek re-election, however, Palumbo-Sanders has chosen not to run again. The third seat opened after former Board member, Michael Vistocco, submitted his resignation on May 13, 2020, two years into his three year term. The three candidates with the highest number of votes win Board seats. Out of those three, the one receiving the least amount of votes will be assigned to the one year term.
