



What is an ENDOWMENT?

- An endowment is a gift that is invested, and a portion of the resulting income is used for a specific purpose.
- Endowments are established and funded by donors to meet specific needs and often to honor or remember people who have made a significant impact on their lives.
- At the TCA Foundation, most endowments benefit Student Tuition Aid and Teacher Enrichment. The minimum amount to establish an endowment is \$25,000. Currently, there are 48 designated endowments with an average balance of approximately \$80,000.
- The Investment Committee for the TCA Foundation oversees the management of the endowment and is comprised of TCA Foundation board members and highly respected investment professionals.
- One benefit of an endowment is the ability to provide sustained funding. For instance, if a family wants to give \$100,000 to provide tuition assistance for TCA families facing crisis, the family could establish an endowment. For our example, let's use a 10% annual earnings rate. Each year, a portion of the earnings, typically around 5%, will be distributed for Student Tuition Aid, and the remaining earnings will be reinvested in the endowment to ensure sustainability and growth. After 15 years, over \$100,000 will have been distributed in tuition assistance, and both the endowment and the amount of tuition aid given out each year will have doubled.

THE JOSH HUCKLEBRIDGE MEMORIAL SCHOLARSHIP FUND

In the summer of 1998, my brother and his son, Josh, came to see me in Dallas. My brother had recently been through some difficult times—a divorce and loss of a job and house. He was unsure of their next steps. I welcomed them and assured them they had a place to stay until things turned around. With plenty of time on both their hands and knowing they both loved to work out, I suggested they go to TCA to run the track.

My brother had played college football with TCA's then-head football coach, Barry Morgan, and I knew Coach Morgan from growing up in Louisiana. He happened to be on the field that day, and he welcomed Josh to use the weight room and track. As they got to know each other, Coach Morgan discussed with Josh how he should consider TCA for high school, and Josh knew then that he wanted to be a Trojan. Knowing my brother's situation, Coach Morgan advised there were scholarships available to help with Josh's tuition. We asked the Lord to guide us with this unbelievable opportunity, and Josh was accepted to TCA for the fall of 1998.

From the beginning, TCA took Josh in and made him feel welcomed and loved. I remember vividly Josh coming home with a smile on his face telling me how awesome TCA was. Josh loved his friends, teachers and coaches. I witnessed an amazing transformation with Josh. He developed into a fine young man, a leader, and his relationship with the Lord was inspiring to everyone who knew him.

Josh graduated from TCA in May of 2000 with academic honors, all-district honors and a football championship. Josh also received scholarship aid to go to Austin College.

The community that Josh witnessed daily at TCA was unbelievable to me. I remember one day he came home with a new heavy coat. I said, "Nice coat," and Josh replied, "Some of my classmates bought it for me." I was in awe of their generosity. When Josh graduated from TCA, one family gave him a used car. Another family gave him \$10,000 to help with college expenses. Yes, \$10,000! Words can't describe how much our family was grateful for the generosity and love the entire TCA community showed.

Soon after college graduation, Josh had the opportunity to work with one of his TCA classmates in aviation sales. On February 27, 2011, I received a phone call no one ever wants to receive. Josh was on a business trip to the Middle East, his plane had crashed, and all four on board had died. This was the worst moment and time in my life to date. Josh was like a son to me. I spoke with him daily and invested an extraordinary amount of time in his life. It was gone in an instant.

After some time, Tina and I felt led to create a memorial in Josh's name at TCA. I called Becky Lewis, the director of the TCA Foundation. Becky helped us through the process, and the Josh Hucklebridge Memorial Scholarship Fund was established with the help of many generous families. The fund is invested with TCA's endowment, and a portion of the earnings each year provide Student Tuition Aid specifically for children in single-parent families who are facing financial hardship.

The Josh Hucklebridge Memorial Scholarship Fund is a special way for our family to continue Josh's legacy as it provides an exceptional education to deserving students in a Christian culture where the love and grace of the Lord Jesus is manifested daily in the classrooms and hallways of TCA.
