Student Tuition Annual Rebates.

The Shop with Scrip organization partners with NVCA to reduce tuition costs for our families. They do that by offering rebates for gift card purchases to local and national retailers. The website is shopwithscrip.com.

#### Who is eligible to utilize this program?

Anyone. Parents with a child enrolled in NVCA in the 2 year old program to 12<sup>th</sup> grade can use rebates to lower tuition.

#### Can others purchase gift cards and direct the benefit to my child?

Yes. We encourage family and friends to contribute to your child's tuition. They just need to designate your child as the recipient on their registration form.

# What if I am not looking for a tuition reduction program but want to participate? Can I donate my rebates other places?

Absolutely. You can either designate another child to receive the tuition rebate or you can make the donation directly to NVCA.

#### Is there a cost to use S.T.A.R.?

Yes. You must complete a S.T.A.R. registration form and submit that with a \$10 registration fee (per family – family and friends do not pay an additional registration fee). There is also a 15 cent processing fee per order.

#### What kind of rebates can I expect?

Each retailer has different rebates attached to their cards. Rebates range from 1.25% to 23+%.

#### How much of the rebate goes toward my tuition?

92% - Tuition 8% - Administration fee

#### Can I use my rebate towards uniforms, milk or hot lunch?

No. This is strictly a tuition reduction program or a donation to the Annual Fund.

#### How does this affect my taxes?

Simply stated, not at all.

You do not need to claim your rebate as income.

Nor can you claim your purchasing of Scrip as tax deductible (even for a business).

The exception to this rule is a donation of Scrip of over \$250.00 for which you have received a receipt from the organization to which you donated. (See STAR coordinator for further explanation.)

#### How often will the rebate be paid out?

The S.T.A.R. Program will pay out on the following times\*:

August Applied to September 5<sup>th</sup> tuition
December Applied to January 5<sup>th</sup> tuition
April Applied to May 5<sup>th</sup> tuition

\*Dates are subject to change.

Rebates will be submitted to Jacque Reed for processing. Mrs. Reed will be the only person making adjustments to each family's account.

#### Do I order online or hand in a paper order at the office?

All orders are done online. Shop With Scrip uses PrestoPay, which drafts monies directly from your checking or savings account. There is a 15 cent fee PER ORDER through PrestoPay. At this time, Shop With Scrip does not accept credit cards to pay for transactions. We do not accept checks at any time.

#### Who can pick up my order? When is it available?

Parents must sign for gift cards in person, or sign a release statement authorizing their child to bring the cards home (students K-12 only). **Orders must be placed by Sunday at 3:00 p.m.** Cards will be available for pick-up during the after school pickup time frame on Wednesdays. Any orders not picked up that Wednesday will be given to Jacque Reed to hold and arrangements will need to be made with Jacque to receive your order.

#### Can I return a gift card that I ordered?

No.

# What if my order is processed and due to Non Sufficient Funds, my check payment is returned?

If the order has not been shipped yet, then the order will be cancelled. If the order has been shipped, you must make full payment for cards and pay any fees incurred by NVCA prior to release of the cards.

#### Who do I contact if I have questions about the S.T.A.R. Program?
