Summer Programs: Delivery Models

- "Synchronous," live remote lessons for students who are able to join on a schedule
- 2. "Asynchronous," recorded remote lessons for students who need flexibility in the timing of instruction
- 3. Print materials distributed via mail or food distribution sites for students who need this option
- 4. Limited in-person being considered for special education

Most programs to run July 6 – 31, Monday – Thursday

Students have the option of keeping their device throughout the summer. Schools will be coordinating device check-in at the end of summer.

Invitation Programs: Elementary

Elementary Summer Literacy Academy - focuses on building foundational literacy skills. 600 grade K-3 students who are at-risk for reading difficulties, including dyslexia, have been invited to attend.

Title 1 Summer School - focuses on building academic skills in reading, writing, and math. 160 grade K-5 students have been invited to attend.

Long-term English Learner (LTEL) – focuses on building academic vocabulary and concepts for students who have been designated as Long-term English Learners (students who have been identified as an English Learner for more than 5 years). 80 5th grade students have been invited to attend.

Families being contacted directly starting June 2.

Invitation Programs: Secondary

Competency-Based Credit Recovery - supports students in need of credit recovery in core subjects through use of Fuel Education, a competency-based online credit recovery curriculum, with ongoing live teacher support.

English Learner (EL) English Credit Recovery - uses the English Language development standards curriculum to support students who need to recover an English credit to graduate on time.

We are in the process of identifying eligible students for each of these programs and will send invitations directly to students and families.

Core Academic

Lexia: Reading K-5, Dreambox Math K-5 and ALEKS Math 6-8 available to students until July 31 at no cost to families.

Algebra 1: Acceleration option for students entering grades 9-12. Taught using an online platform by a Fuel Education certificated teacher.

Geometry: Acceleration option for students entering grades 9-12. Taught using an online platform by a Fuel Education certificated teacher.

Algebra and Geometry are fee-based programs - \$810/credit with a sliding scale for students who receive free or reduced-price lunch

Information about math courses and enrollment will be posted on our website on June 2. Online registration available 6/3 - 6/26.

Special Education: Extended School Year (ESY)

- ESY services means services provided to a student eligible for special education beyond the normal school year; in accordance with their IEP; and provided at no cost to families.
- ESY services must be deemed necessary by the IEP team and are meant to maintain student learning skills and behavior (not teach new skills).
- Teams determine eligibility for ESY services at the annual IEP meeting by reviewing data and considering regression and recoupment of skills and critical learning stages.

Extended School Year (ESY) Planning

- ESY will run in July in coordination with Summer School and will be a virtual instructional model.
- 22 preschool/elementary students and 17 secondary students are eligible and signed up to participate.
- Staff survey indicates a total of 52 staff are willing to provide instruction (including both para-educators and teachers therapists are to be determined).
- Currently in process of determining which of these 39 students may be unable to access virtual 1:1 and/or small group learning.
- In-person services will be considered for these students based upon state allowances and availability of staff.

Extended School Year (ESY) Planning

- Students in ESY will continue to have access to technology.
- Students currently receiving in-person instruction will be eligible to continue services over the summer.
- Students placed in Non-Public Agencies (NPAs) will continue to access their programs as offered.
- Special education students will have the ability to access and participate in district summer school options.
- ESY will be provided in real-time with teachers and students.
