Superintendent Cordon noted his appreciation for the Roseburg School Board's visionary leadership in developing the 2020 bond proposal. On May 20th, districts expect significant budget decreases reported in the State Revenue Forecast. Jared did remind the Board of the legislative and political budget process that could continue throughout the summer. Our district will be involved in both processes and we do

Revised Policies Presented for First Reading

Human Resources Director, Robert Freeman, shared Policy JHFE-AR: Reporting of Suspected Abuse of a Child, to accompany Policy JHFE.

Teaching and Learning Director, Michelle Knee, also presented the revised policies as follows:

Policy IGBB: Talented and Gifted Program;

Policy IGBBA: Talented and Gifted Students-Identification;

Policy IGBBA-AR: Appeal Procedure for Talented and Gifted Student Identification and Placement; and

Policy IGBBC: Talented and Gifted — Programs and Services.

The Board approved all of the above policies and associated ARs for First Reading.

Resolution 19-20-15 Adopting Supplemental Budget for 2019-2020

Chief Operations Officer, Cheryl Northam, presented the proposed resolution revising the adopted budget based on Board guidance to increase the Debt Service Fund balance to submit a lump sum payment to PERS in order to reduce the District's Unfunded Actuarial Liability and further reduce the District's employer rate paid on all qualifying payroll.

The Board approved the proposed student fees for 2020-2021. Superintendent Cordon emphasized that there are no increases in the fees for next school year. If changes are needed once the State provides clear direction for how Oregon schools are to operate within potential social distancing restrictions this fall, any resulting impacts to student fees will be brought to the Board for consideration.
