I do not give you permission to search any of my belongings based on my 4th Amendment rights.

Protocols For All Staff & After-School Providers



Protocol for student abandonment due to parent deportation

February 2, 2018

What is the protocol if a student is not picked up from school due to deportation?

1. **Check emergency card and contact listed individuals**
 - a) Make sure they are updated (Parent Link as a reminder)
 - b) After school providers should have access to office emergency cards as well as their own.
 - c) Recommend to parents that they provide emergency contacts that have legal status in the U.S.
2. **Notify District Administrators**
 - a) Text 408-687-0408 / Supt Office
 - b) Call/text 408-307-3129 / Student Services Director
Call/text 408-687-0355 / Afterschool program Director
3. **Home visits should be conducted as a last effort to contact family**
 - a) Community liaison
 - b) Administrator
4. **Provide information for access to legal services**
 - a) Immediate Immigration Support: (408) 290-1144
5. **Contact Social Services Department**
 - a) (408) 299-2071
6. **Contact Police department**
 - a) (408) 277-8900

Other important notes:

Staff should check for appropriate ID for any visit from law enforcement (including ICE)

Staff needs to be familiar with the district protocol for this type of incident



Alum Rock Union Elementary School District Rights of Staff

Must we allow ICE and other government authorities on your campus?

No. School districts have the right to limit the amount of disruption to the learning environment and to ensure the safety of their staff and students, which may include denying an individual from accessing a campus during school hours. (Education. Code §§ 32212, 35160.) Entry to all District properties is to the discretion of the Superintendent and inquiries should be directed to the Superintendent's Office.

Staff is to treat ICE and other government authorities on your campus as you would any other guest should they show up at your school:

- Request that the agent sign in at the front desk
- Request that the agent provide valid identification and statement of purpose
- Inform the Superintendent's office of the request

*****NOTE - Immediate access to the student should be given ONLY if the agent has a warrant or a court order. Please note: Check with Superintendent's Office before allowing access.**

Are we required to allow ICE or other government authorities to have access to student records?

No. Requesting agency must have a valid court order or subpoena. All requests for such records should be directed to the Superintendent's office.

If a parent is in custody as the result of immigration enforcement, are we required to release the student to ICE or other immigration officials?

No. School districts are not required to release students into the custody of ICE if their parent is in custody as the result of an immigration enforcement action. Staff is to reference Emergency Cards and attempt to release students to those identified individuals.

Communicating to Families

There is a Parent Link going out today, 2/2/18, to all families emphasizing the importance of current, updated Emergency Cards so what we can ensure the release of students to the appropriate individuals. We are asking staff to echo this message to your community in your daily conversations.

Alum Rock is committed to the safety of our students and families and we are working to assemble further resources to affected families.
