Discussion Items

Review school-wide data: We did really well last year. Priority performance challenges:

1. Low median growth in KG and 1st on iReady.
2. Social/Emotional Learning: Kids report, “Students in my school get mad when they disagree with people.”
3. Math: Minority students in math was 55% which was 20 percentage points below other subgroups in math.

UIP:

Root causes

1. System of Intervention/Enrichment Support for all students: lack of consistent structures of resources to implement appropriate interventions for all students
2. High Quality, Consistent Literacy Instruction: New, consistent literacy tools
3. Lack of consistent, school-wide SEL strategies and/or curriculum: Eric is FT, we have consistent SEL programming now

Goals

1. SEL: Going to implement 36 week Mindful Life program
2. Literacy programs in use: Fountas Pinnell and Foundations in PK/K
3. Use VizLab data to monitor and document student progress toward reading growth goals as part of MTSS process. MTSS is really up and running this year.
4. Send staff (Donna Wilson and Julie Parks) to professional learning opportunities on culturally proficient practices for MTSS to assist in reducing the overidentification of Latino students
5. iReady Winter: 6% at risk for tier 3, 28% tier 2, 66% at tier 1

FRS Updates

- a. After-school data: Winter 65% full fee, 22% reduced fee, 12% scholarship; Fall 57% full fee, 26% reduced, 13% scholarship
- b. Participation: W 2018 31%, Sp 2018 39%, F 2018 42%, W 2019 35%
- c. Less participation in 3-5 grades

- e. Mental Health Services thus far 21 families served this year
- f. Hispanic Focus Group-3 families; will resend survey follow-up
