- a. Special Request Presentation by Sedgwick Middle School 7th graders: 3 seventh graders presented a very unique proposal to generate electricity for their school namely the use of piezoelectric floor tile in the stairwells to generate electricity as students walked on the panels. It was suggested that they review other installations in India and Sweden. The Commission was very pleased to explore this idea further.

- b. Discuss: Electric Vehicle Display Town Hall Parking Lot September 21, 2019 9AM to 1PM: This event was organized without knowledge or participation by the Commission. It was sparsely attended and not well promoted. Recommend that the Commission get involved next year and possibly look for partners such as was done in 2018 with Kingswood Oxford.

- a. Review Discussion with Mayor Cantor:
 - Should WH declare a climate emergency?_It was decided that Bernie Pelletier and Julia Farber would draft a 100 Percent resolution (not a climate emergency) for the Commission to review.

 - Fellowship Housing, Fintech ...other projects in town ...? As noted above the Commission will send a letter to Fintech management

- c. Sister City task force report Town Manager discussion review: Matt Hart has accepted the task force's report. Two key items came out of the effort – 1) that the town will explore – as a matter of course – other municipal efforts when considering a project and 2) that the Commissions will endeavor to work as partners (WHCEC, The Pedestrian and Bicycle Commission, and the Conservation and Environment Commission.
