### 3. Communications/Administration

- a. Freedom of Information workshop for town Dave Mello attended (2 months ago)
- b. Fellowship Housing Project

This is a new construction project of affordable senior housing across from Bishops Corner Library. 20H Starkel Rd. It is a non-profit but on Town-owned land. Sonja Davis, President of Board of Fellowship Housing, met Catherine at MDC meeting. Catherine has since met with Mark Garilli of Construction Solutions Group, their owner's rep for redevelopment. Only 1 building (gas heat) with 40 Section 8 units will remain. They are tearing down 23 of 24 buildings with (all electric resistance heat) and rebuilding 6 large building. Total units are increasing from 218 to 308. Great opportunity for green design or even Net Zero. They are early in the process. Catherine has connected the project team to Eversource New Construction (focus on HERS rating) and C-PACE programs. Baecuase building are on Town land we should have a say/stake in their energy criteria. The WH-CEC will draft a letter of support for a Net Zero replacement standard for these buildings.

c. Land trust approached WH-CEC about Trex plastic challenge.

We approved by vote that WH-CEC would cosponsor. We've also heard that the rotary club may be interested and potentially we'll work on this together. Catherine will also put them in touch with the Conservation and Environment Commission

d. Update on combining with Conservation and Environment Commission

No additional news, Catherine's meeting with Todd has been postponed several times.

#### 5. Business

a. "TED" talk - Sam King - Blue Earth Compost

Samuel King of Blue Earth led a discussion of the progress that Blue Earth Compost is making in West Hartford and surrounding towns. Blue Earth has composting services for Residents, Businesses, and Events. Currently Blue Earth has about 250 residential customers in WH and 150 in surrounding towns. The service <u>currently</u> costs \$30 per month for weekly pick-up and \$20 per month for every other week pick-up. They are encouraged by the growth which will enable them to keep their costs per pickup low. They are interested in expanding to cover as much of the town as possible. The CEC discussed the concept that because food recycling requires attention on the part of residents – it may wise be to grow this service from the bottom up rather than instituting a town wide service. The latter option would be expensive and would have many residents who would not participate. Blue Earth spends time to ensure that the material that they send to Quantum BioPower is properly sorted.

- b. WH-CEC participation at Celebrate West Hartford
  - Highlight Energy Resources WH-CEC can't endorse a specific company.
  - Use SustainableCT as an outreach bridge the WH-CEC elected to focus on renewable energy and energy efficiency using the town's progress as example. SustainableCT will be mentioned.
  - Resources to help residents recycle properly WH-CEC will be near Paine's booth and we will work with them so they deliver that message and sorting game.
  - Graphics displaying WH Municipal progress
    - We will make 2 or perhaps 3 graphics showing the town's energy progress (Joe C to check printer)
