Chair Commissioner M. Margolis called the meeting to order at 5:01 P.M.

1. New Business-

a. Katherine Doyle, owner of 1564 Boulevard, came before the West Hartford Historic District Commission (WHHDC) to discuss her request for a Certificate of Appropriateness (COA) for a black metal fence around the rear perimeter of her property to keep in her rambunctious young pup. There were no public comments. Chair Margolis motioned to vote on the COA and Commissioner Cormier seconded the motion.

The WHHDC voted unanimously to approve the COA and Chair Margolis will inform the Building Department at the next earliest convenience.

b. Graham Chase Jr, owner of 1596 Boulevard, came before the WHHDC to discuss his COA to remove and replace his existing asphalt driveway with same and in the same footprint. There were no public comments. Chair Margolis motioned to vote on the COA and Commissioner Cohen seconded the motion.

The WHHDC voted unanimously to approve the COA and Chair Margolis will inform the Building Department at the next earliest convenience.

c. Monte and Suzanne Henderson, owners of 66 West Hill Drive, came before the WHHDC to discuss their COA to replace their delapidated wooden rear yard fence with a new wooden fence of the same dimension. There were no public comments. Chair Margolis motioned to vote on the COA and Commissioner Harris seconded the motion.

The WHHDC voted unanimously to approve the COA and Chair Margolis will inform the Building Department at the next earliest convenience.

d. Michael Barlow and Paige Kenausis, owners of 1605 Boulevard, came before the WHHDC to discuss their COA to remove and replace their existing asphalt driveway with same keeping the original footprint and adding an additional bump out to accommodate a single automobile. There were no public comments. Chair Margolis motioned to vote on the COA and Commissioner Cormier seconded the motion.

The WHHDC voted unanimously to approve the COA and Chair Margolis will inform the Building Department at the next earliest convenience.

2. Meeting Minutes-

Motion to approve the West Hartford Historic District Commission Regular Meeting Minutes for January 27th, 2020 was made and seconded.

The WHHDC voted to approve the meeting minutes with Commissioner Lewis abstaining.
