- a. SAPC Membership Progress Update
  - i. Rep for Superintendent tabled until next meeting when member is present
  - ii. Membership outreach: the commission would like to gain voting members from the following sectors/organizations: True Colors and/or members from LGBTQ community, any clergy or religious leadership, business community, doctors/dentists/pharmacists, and a student from each high school; we are looking for 3-4 committed people to hold a voting position; Carl Shields and Nordia Napier will reach out to True Colors
- b. Update on Prescription Drop Box in West Hartford: Lt. Michael Alquist
  - i. Box was officially opened on 12/17/18; has been open for 3 months; the box is very small for 60,000 residents; the intent was to target the removal of opioids and narcotics, but some residents are using it to "clean out their cabinets"; there is a need to reeducate the public on the proper use of the drop box; SAPC is not tasked with doing any advertising or anything else besides advising town council; the WHPD has a link on their website and Facebook re: the proper use of the drop box

- c. DPH Opioid Surveillance Report: Helen Drohan, RN, BSN
  - i. Helen Drohan presented the surveillance report; statistics were passed around and will be sent out via email, post meeting
- d. Update on High School Survey
  - i. Survey for 2019 has been submitted and is underway; includes data on drug use tracked for 6-7 years; the data will be available for presentation in the early Fall 2019.
- e. Reminder of national prevention week, May 12 18
  - i. WHPP will be creating activities throughout the week; focusing on alcohol and tobacco (specifically vaping); tobacco awareness (vaping) event will be held during athletic events at the high schools; a teen from the teen center will be making announcements at the high school
