- Expense, there has been more movement, staffing with retirements and some change with the reduction of the Tech Aides
- Board approved some Capital Projects
- Salaries and benefits about 70% of the budget
- Have the final medical rates
- Little movement in Special Education
- Great renewal on Workman's comp
- We are now at a 2.67% tax increase. The rate will change in the next couple of weeks to maybe 2.4% or 2.3%
- Next year will be the last of the big jump in the pension plan
- Millage rate is 18.1460 mills, lowest in the County

- c. Motion: To approve the 2014 Homestead and Farmstead Exclusion Resolution, as presented.
