## A. High School Renovation and Addition Project updated present by Reynolds Construction Management Bill from Reynolds gave the following report

- > 95.5% complete on cost basis
- > 995 days complete out of 1,026 day project 97% complete
- ➤ 2 million still to be billed
- ➤ 2.4 million retainage
- ➤ Phase 1-11 punch list being worked on
- ➤ Contingency exposure 2.4 million
- This amount includes change orders for back parking lot
- ➤ Used credit for enhancement
- ➤ Also includes credit on screens
- Metal Panels have been delivered with the exception of a few

- ➤ Thin brick solutions trying to make corrections~ not done as of yet
- ➤ Library wall complete
- > Still have links in the Library
- > Have roofer and agreements, materials are also here
- > Flood and gravel work done before students come back
- > Auditorium done before school, probably not
- Fire pump resolved waiting on final decision

# C. Gauntlett Center Renovation Project update presented by Reynolds Construction Management.

The following report was given

- > 97% complete on cost
- > 94% complete on time
- ➤ No change orders
- > Day by day schedule to accommodate needs
- Some exposure, exterior wall needs extensive repair, between \$80,000 to \$100,000 to complete
- ➤ Upgrade exterior areas, courtyard, doors, windows
- > Entrance for registration for Leisure Services
- ➤ Comments ~ parking needs to be done before start of school. The courtyard parking is for Cabinet and visitors

#### **D.** Grounds Department Presentation

Mr. Dumin gave the following presentation

- > Grounds, 1 supervisor, 3 grounds workers, 1 seasonal
- > Gave description of the size of the propertories
- ➤ Responsibilities, field prep, grounds, parking lot, snow removal, grass cutting, playground maintenance, (includes increasing the decreasing the size of the playground equipment)
- ➤ Material movement
- Maintain all equipment
- > Project sign management
- Grounds project, behind the bleachers, foliage needs to be cleaned up
- ➤ High School front area, planting area
- > Fence repairs
- Grounds crew to be license to properly take care of the lawns

- Some staff reassigned, custodial staff to help with grounds, and grounds crew reassigned in the winter to help with indoor repairs
- ➤ Funds needed ~ 5800 High School, \$375.00 for front and side, \$3,660.00 for Administrative offices, \$285.00 for Curb appeal
- ➤ Budget for contractor \$12,000.00
- Seeding and aerating separate cost
- ➤ Need to see how the year goes, may have to increase budget, depends on snow removal
- Pesticide license cost about \$1,000.00 for 2
- ➤ Gave a report on the gym at Paxon Hollow, painted and gym floor redone.
- Window cranks at the High School removed, patched, and painted
- Mr. Dumin also going to ask for a motion at the Full Board Meeting for the disposal of the switch gear from the Gauntlett Center
