Board Briefs from School Board Meeting Dec. 16, 2019

Strategic Plan

In May of 2016, The D70 Strategic Planning Committee assembled to collaboratively develop our district's strategic plan. This is a living, breathing, vibrant document that has and will continue to focus our energies to continuously improve opportunities for our students, families, staff and the larger community of Libertyville. The committee's efforts on this and the product itself are worthy of replication and deserving

At the end of each year, the progress that has been made on the District 70 Strategic Plan is shared on the district's website in the [Dashboard Tab](#). In addition to continuing this practice, the committee will reassemble after winter break to receive highlights where progress has been made in each goal area as well as to provide their input on recommendations that administration would like to add to the plan to continue keeping it current and reflective of our district's needs.

The Committee will reassemble on January 25, 2020, from 8:00 a.m. to 10:00 a.m. at Butterfield Elementary School. Dr. Bob Madonia, who facilitated our last two strategic plans, will be our guide for this conversation.

Dr. Madonia, Dr. Barbini, and cabinet members provided information to the school board on

how January 25 will be structured along with recommendations that central office and building administration are proposing to continue keeping our plan current and reflective of our District's needs in the presentation below.

Dr. Erik Youngman provided a brief overview of recent areas of focus for social studies in Libertyville District 70. Updates were shared about National Geographic Resources that are being used at Highland Middle School and resources that elementary schools are reviewing for social studies.

Website

The School Board approved a contract with Finalsite to provide a new website for District 70 beginning in the 2020-21 school year.

At the November School Board meeting, Mrs. Robin Kollman, public relations coordinator, and Mr. Dmitry Andrievsky, director of technology, discussed that the current D70 website no longer meets our needs based on the following factors:

- Results from a parent engagement survey conducted in 2018 identified that information is difficult to find on the district's current website and that it is not intuitive or easy to navigate.
- The current website does not give District 70 organizational flexibility because it was built from scratch and is maintained by one employee.
- The current website is housed onsite and susceptible to local power outages.

Finalsite was chosen after careful review because this website solution met the following criteria:

- An intuitive, user-friendly interface built first and foremost on accessibility on mobile devices.
- A modern look and layout that more closely reflects the D70 brand;

- Assists with compliance requirements for website access established by the American Disabilities Act.
- Meets the district's need to tell our story and communicate while also being a solution that integrates well with other existing systems and is not labor-intensive to implement and manage.

The startup cost for Finalsite will be \$11,000, followed by annual costs of \$12,000 each year through to July 1, 2024.

This is also one of Dr. Barbini's goals this year.

Policy

The administration and school board use a policy subscription service provided by the Illinois Association of School Boards as the basis for developing, reviewing, recommending, and approving policy language. This service is used by the majority of school districts in Illinois and is known as the Policy Reference Education Subscription Service (PRESS).

Policy Approvals

Following the required second reading of recommended policy language, the school board approved changes to the following policies:

4:15 **OPERATIONAL SERVICES:** Identity Protection

This policy describes the appropriate use and protection of personal information, primarily Social Security numbers. Also described are required training for staff who handle this information, as well as notification requirements.

5:170 **GENERAL PERSONNEL:** Copyright

This policy covers three topics:

- Any instructional materials or computer programs created by staff during the scope of their employment is the property of the district;
- Staff is expected to follow all rules of copyright. Staff should not have to violate copyright laws to perform the essential functions of their jobs. The District is not responsible for staff or students who violate copyright laws.
- A copyright infringement agent is created and named.

5:200 **PROFESSIONAL PERSONNEL**: Terms and Conditions of Employment and Dismissal
This revision is a minor update to previous versions and includes references to the school year, the school day, salaries, assignments and transfers, dismissal, evaluations, and limits on social workers. Many topics are covered under the PNA, and numerous references are made within the policy.

5:300 **EDUCATIONAL SUPPORT PERSONNEL**: Schedules and Employment Year
Revisions to this policy include re-wording of flexible work schedules, responding to changing circumstances, and breaks

5:320 **EDUCATIONAL SUPPORT PERSONNEL**: Evaluation
This policy outlines the components of, and process for the evaluation of non-certified staff.

6:10 **INSTRUCTION**: Educational Philosophy and Objectives
This policy includes the enumerated items related to the District's educational philosophy and objectives.

Superintendent's Report

ALICE Training

The foundation that everything we do as educators is built upon safety. This requires a commitment to continuous growth and improvement. It is with this in mind that D70 will be implementing ALICE in the 2020-2021 school year. ALICE provides staff and students with additional strategies to employ should they ever face an armed intruder situation.

Planning efforts are underway to implement ALICE. A big first step was taken toward implementation earlier this month as each building principal, a representative staff member selected by each principal, and central office administrators participated in a two day ALICE training on December 4 and December 5.

An ALICE implementation committee comprised of teachers, building administrators, and central office administrators will begin meeting in January to plan for all aspects of implementation in the fall and beyond!

Character & Leadership Award

Libertyville School District 70 honored Libertyville Township Supervisor Kathleen O'Connor as this year's District 70 Character & Leadership Award recipient during the Dec. 16th School Board meeting.

O'Connor, a beloved Libertyville resident who raised all her children in District 70 schools and grew up in the village, exemplifies the traits of the character-building program used in District 70

schools, including trustworthiness, respect, responsibility, fairness, caring, and citizenship, according to Holly Simon, Butterfield speech-language pathologist, who nominated Mrs. O'Connor for the award. Simon noted that Mrs. O'Connor is "hard-working, always ready to be there for others in all aspects of her life," even during non-working hours.

District students, families and teachers often collected items for the Libertyville Township Food Pantry, which Mrs. O'Connor supervises and directs. The pantry helps supply food to those in need.



The distinguished Character & Leadership Award is the only award District 70 bestows on a community member or group in appreciation for their "honor of exemplary character, leadership, and service." The award is given with appreciation by the Board of Education, administration, and staff. District 70 also honors an employee with the award at the end of the school year.

The award has been given for the last 10 years to someone who "through their service, character, and leadership exemplifies true dedication to the children, families, and staff of our learning community," said Character Counts Committee member and Rockland kindergarten teacher Dale List said. "The nominee's beliefs, attitudes, and actions consistently exemplify the six pillars of character."

Nominations for the award are made to the committee and the committee then selects how meets the criteria.

“Kathleen is a lifelong resident of Libertyville where her strong sense of community runs through her veins,” Simon noted in her nomination. “Mrs. O’Connor is driven by her heart of gold as she lives her personal and professional life by a code of ethics. Responsibility is Kathleen’s guide as she fulfills her duties as Libertyville’s Township Supervisor with accountability and excellence. Fairness, Caring, and Citizenship are additional characteristics that complete our reasons for nominating Mrs. Kathleen O’Connor for the 2019 Community Member Award of Character.”
