# COVID-19 TASKFORCE MEETING May 21, 2020

A summary of the meeting has been created, incorporating the chat from Zoom. Conversations have been chunked and answers highlighted. Where questions or comments were acknowledged within the meeting, or comments stood on their own, no additional information was added.

#### Superintendent Polly Bove welcomed the group and explained that the emergency

operations report would not be presented today. If there are changes in the future, the report will be presented. Student attendance remains high and meals continue to be provided.

Associate Superintendent of Student and Special Services Trudy Gross shared that with the update in Public Health guidelines, car parades were being planned for each school on June 4 prior to the virtual graduation ceremonies. The COVID-19 and College page on the District website now contains information about Collegewise webinars and an opportunity to add to the Frequently Asked Questions. A remote learning survey is in the process of being drafted will be sent to all students, families, and staff next week.

## Associate Superintendent of Human Resources, Employee Development and Instruction

Tom Avvakumovits reviewed the outcome of the progress report narrative comments (attached) and a process for students in the class of 2021 to request letters of recommendation.

From Polly Bove to Everyone: 04:11 PM both good questions we will get you the answers. All teachers provided comments; there is a 250-character limit in the box for each course.

From a parent to Everyone: 04:12 PM Regarding the letters of recommendation: The guidance counselors said students could ask just 2 teachers to write, like in the past. Not sure how this is different from the past.

There are three differences in this year's process for letters of recommendation: site coordination with teachers about writing letters and the potential increased volume; timing of the letters; and incorporation of information about the student specific to the time of school closure.

From a student to Everyone: 04:12 PM is there an update on whether or not students would be able to include first "progress report" grades, but not the comments, or vice versa? The Remote Learning Report will be made available to all students. It will include a school closure grade, semester 2 C/NC and comments.

From a teacher to Everyone: 04:13 PM Is there a system for tracking the 2 teachers so that students aren't asking more than 2?

From Kami Tomberlain to Everyone: 04:15 PM (Teacher), we're trying to track through the survey...(we have) a plan, though it will be challenging to be sure. From the same teacher to Everyone: 04:15 PM Gotcha :) From a parent to Everyone: 04:16 PM Some teachers are not convinced the progress reports are that important. Students got incorrect grade (e.g. they had an A grade on 3/13 but are now showing a B in progress report). How can this be corrected? How can we communicate to teachers that students, some at least, are taking these progress reports seriously? Principals sent a message to their staff about the importance of the process and oversaw the process while the grading window was open.

From a teacher to Everyone: 04:17 PM Even if the letters of rec aren't any different in real life, it's a very calming message to send to kids.

From a student to Everyone: 04:18 PM I would like to know the answer to (student's) query above as well. From a student to Everyone: 04:19 PM As would I

From a parent to Everyone: 04:22 PM And the option to include the "School Closure Grade Report" and nothing else (i.e. no commentaries, no 1st progress report grades, no subsequent grades). It might be best to plan for full distance learning, as that is a real possibility, and then if we can do some physical learning, that will be a bonus and easier to adapt to than physical to remote learning. Can we find out how full distance learning will be implemented? Specifically, how to do remote assessment, as that was the big stumbling block this semester. More information about schedule planning will be shared at the TF meeting on 6/11. Our Teaching and Learning administrators and Curriculum Leads are putting together webinars and other resources to assist teachers in a number of aspects of remote learning, including assessment.

**Polly reviewed potential scenarios for the opening of school in August. There is a** consultant through public health who will be working with the 32 districts in Santa Clara County to support school reopening.

Check any and all of the scenarios that apply.

- If allowable, I will be comfortable having my student(s) attend school for "in-person" learning.
- If allowable, I will be comfortable having my student(s) attend school for "in-person" learning with some online distance learning.
- I prefer the option of online distance learning (similar to the current practice with modifications based on what we learned this spring).
- *I am not comfortable with any of these scenarios.*
