MOTION: Move that pursuant to Connecticut General Statutes Section 10-233d, the Ansonia Board of Education shall expel the student discussed in executive session from attendance at Ansonia Middle School for the period from October 27, 2017 until end of the 2017-18 school year, for the reasons presented by the School Administration in this hearing and admitted to by the Student and the Student's parent.

Further, the Board directs the School Administration to establish and offer an alternative educational opportunity to the student for the period of this expulsion, pursuant to Connecticut General Statutes Section 10-233d(d), which should include at least ten (10) hours of tutoring per week and be in compliance with State department of Education regulations.

The Board further directs the School Administration, pursuant to Connecticut General Statutes Section 10-233d(f), to record this expulsion on the Student's cumulative educational record, to be expunged from such record if the Student graduates from high school, or as in accordance with the Board's then-existing policies and/or State law.

Finally, the Board authorizes William Nimons and Attorney Fred Dorsey to communicate in writing to the Student and/or his/her parents/guardians/attorney, as appropriate, the Board's decision and the reasons therefor, consistent with the Board's executive session discussion.
