OFF CAMPUS PERMISSION FORM

We expect students at Bellevue Christian School to demonstrate a high level of responsibility. In demonstration of that trust, BCS allows students, under certain conditions, to leave campus during school hours. For underclassmen, this privilege applies only to long lunch and Tuesday/Thursday Office Hours of each school week. One of those conditions is parental consent. Only those students having a signed permission slip on file will be allowed to leave campus. Parents should guide their child about offering or requesting rides with other students during lunch time based on insurance coverage and personal philosophy. The school is unable to supervise ride arrangements.

Students must sign out and sign back in at the front desk whenever they leave campus.
