Instruction Mandates for Health Education

❑ **California Healthy Youth Act (2016), EC 51930-51939.**

These sections of the Education Code address both comprehensive sexual health education and HIV Prevention education. The law requires that both are taught once in middle school and once in high school (grades 7-8 & 9-12).

❑ **Five Primary Purposes:**

- Knowledge to protect sexual and reproductive health from **HIV, STIs and unintended pregnancy**
- Knowledge and skills needed to develop **healthy attitudes** concerning adolescent growth and development, body image, gender, sexual orientation, relationships, marriage and family
- Knowledge and skills to have healthy, positive and safe **relationships and behaviors**
- Promote sexuality as a normal part of **human development**
- Ensure pupils receive **integrated, accurate, comprehensive** and unbiased sexual health and HIV prevention instruction; provide educators with clear tools and guidance to provide instruction

Are schools required to teach comprehensive sexual health education and HIV prevention?

- YES! The state legislation, originally known as AB 329, requires that students in grades seven through 12 receive comprehensive sexual health education and HIV prevention education at least **once in middle school and once in high school.**
- School districts can **select their own curricula** under the leadership of their locally elected boards and superintendents.

Can parents opt out of sex education lessons?

- **YES!** The law makes it clear that parents **CAN** opt their children out of comprehensive sex education.
- According to the language of AB 329:
“The Legislature recognizes that while parents and guardians overwhelmingly support medically accurate, comprehensive sex education, parents and guardians have the ultimate responsibility for imparting values regarding human sexuality to their children.”

Can parents opt out of materials that discuss gender, gender identity, gender expression and sexual orientation?

- **YES!** Parents can excuse their child from lessons about comprehensive sexual health and HIV prevention education, as well as research on student health behaviors and risks.
- However, as stated in Education Code 51932(b) the opt-out provision of the California Healthy Youth Act does not apply to instruction or materials outside the context of sex education, including those that may reference gender, gender identity, sexual orientation, discrimination, bullying, relationships or family.

For example, the opt-out rule associated with sex education would not apply to a social studies lesson on the U.S. Supreme Court's 2015 ruling in favor of same-sex marriage.

What are the instructional criteria requirements for comprehensive sexual health education and HIV prevention education?

The law requires instruction and materials to meet a number of guidelines:

- age-appropriate
- medically accurate and objective
- appropriate use with pupils of all races, genders, sexual orientations, ethnic and cultural backgrounds
- affirmatively recognize different sexual orientations and be inclusive of same-sex relationships in discussions
- teach about gender, gender expression, gender identity and the harm of negative gender stereotypes
- teach the value of committed relationships such as marriage

The full list of guidelines is listed in Education Code 51933.

What does the law say about abstinence?

Under AB 329, abstinence may not be discussed in isolation from other methods of preventing HIV, other sexually transmitted infections — or STIs — and pregnancy.

However, the law requires that instruction and materials include information explaining that **abstinence is the only certain way to prevent HIV, other STIs and unintended pregnancies.**

It also states that “Instruction shall provide information about the value of delaying sexual activity while also providing medically accurate information on other methods of preventing HIV and other sexually transmitted infections and pregnancy.”


