



## CAMP MUSTANG COVID-19 HEALTH & SANITATION MEASURES LOWER SCHOOL BUILDING

### GENERAL:

- Only campers and Meadows staff members are permitted in the building unless there is an emergency.

### DROP-OFF/PICK-UP:

Children arrive through the car line only to be screened and signed in at the vehicle:

- A staff member will record the child's temperature and verbally ask the parent screening questions. Child is not admitted to camp with fever or signs of illness.
- Screening questions:
  - Has your child or anyone in your household had a fever over 100 degrees in the last 24 hours?
  - Has your child or anyone in your household experienced a cough, shortness of breath, or a loss of taste or smell in the last week?
  - To the best of your knowledge has anyone in your household been exposed to or contracted COVID-19?
  - To the best of your knowledge has your child been in close proximity to an individual who has tested positive for COVID-19?
- Child that passes screening enters the building and washes hands and receives hand stamp to wash off throughout the day.

Children are picked up through the car line only.

- Children will not sit closely together waiting to be picked up.
- Parents/caregivers do not enter the building.

### STAFF HEALTH & HYGIENE:

- Staff members are instructed to stay home if they are ill and will complete the daily screening, including taking temperature upon arrival.
- Staff members will wash and sanitize hands frequently throughout the day.
- Staff members will wear masks while in close proximity to children:
  - At drop-off and pick-up.
  - During one-on-one or small group instruction.
  - When assisting children with health, clothing or any personal care.
- Staff members will wear gloves:
  - At drop-off screening and putting children into vehicles at pick-up.
  - When assisting children with health or any personal care.
  - When distributing snacks and assisting with lunch (disposable food handling gloves).

### **CAMPER HEALTH & HYGIENE:**

Campers over the age of 10 years old must wear a mask. Those under 10 are permitted to wear masks, but not required. If the mask becomes a distraction parents will be notified.

Campers wash hands with soap and water:

- Upon arrival, before snack time and lunchtime, after using the restroom, after outdoor play and as directed by a staff member, especially after having fingers in nose or mouth or touching multiple surfaces.

Campers sanitize hands:

- When changing locations, in between activities or as deemed necessary by a staff member.

Campers may not share:

- Food items/water bottles.
- Pencils, crayons, basic supplies.
- Manipulatives and other small items.

Campers will be reminded frequently to:

- Keep fingers out of nose and mouth.
- Not put anything into mouth other than food.
- Keep hands near your body while walking.
- Sneeze or cough into your elbow and turning away from others.
- Give everyone their personal space.

For a student who develops a fever or signs of illness while at camp:

- Child will be isolated in the infirmary. Parents will be contacted for the child to be picked up as soon as possible.

### **CAMPER SEATING:**

- In classrooms, children will be seated one or two at a table in an assigned seat. When sitting two at a table the chairs will be one on each end to maintain a distance of six feet between students.
- Two children may share a lunch table, one at each end of the 7' table.
- Children will not sit side-by-side on the carpet.

### **INDIVIDUAL SUPPLIES:**

- Each child's basic school supplies, such as pencils, crayons, scissors, will be kept in individual bags labeled with the child's name. This applies items such as manipulatives, LEGOS and other small objects.

### **CENTERS:**

Children will not play in close proximity in classroom centers.

- Dramatic play and group play have been modified to allow for social distancing.
- Tabletop centers will have children playing with their own items rather than sharing.
- Shared items such as easels will be cleaned between users.

### **PLAYGROUND:**

- Playtimes will be staggered and children will be in groups of 10 or fewer.
- Teachers will assign play areas to children.
- Children using playground equipment will wait for one student to finish before using.
- High touch surfaces such as handrails will be sanitized between play periods

### **FOOD/WATER:**

- Lunch is brought from home (no nuts).
  - Children cannot share food items.
- School provided snacks are individually packaged items only.
- Children will not drink directly from water fountains. Small disposable cups may be used.
- Children may drink water from their own, refillable bottles. Staff will assist with refills.

### **CLEANING DURING CAMP DAY:**

When students are present, only cleaning products labeled safe to be in the room with children may be used. Otherwise, items must be removed for cleaning or cleaned when campers are not in the room.

- Classroom tables, lunch tables, toys, and supplies.
  - Tables will be sanitized between activities or lunch periods.
  - Toys and supplies will be sanitized between users.

### **CLEANING AFTER CAMP:**

An area has been designated for used/soiled toys to be sanitized after hours by the nightly cleaning crew.

- In addition to the normal cleaning and disinfecting at night, extra attention will be given to tabletops, bathrooms, and high-touch surfaces.
- The infirmary will be deep cleaned at night if it is used during the day. Staff will leave a notification on the door after camp.
