I, the undersigned parent/guardian, acknowledge, agree, and understand that:

1. Voluntarily and of my/my athletes own will, my athlete elects to participate in the clinic/game/sport with Capital Christian.

2. I release, discharge, and agree not to sue the team/league/coach/school designated below or the owner, officers, agents, etc., of either the official associations of Capital Christian School/Center for any claim, damages sustained or incurred by me/my athlete.
3. I give my consent for him/her to go with a school representative on any trips and to participate in team activities. I give my consent for him/her to ride with a parent/and/or student to athletic contests and practices that are off campus when school transportation is not available.
4. I understand that a \$100 fee will be charged to your tuition account the week following tryouts \$90 for second sport and \$80 for third sport. Middle School, \$75 for first sport, \$65 for second sport, \$55 for third sport.
