The “Why”...

TEA releases the **Texas Academic Performance Reports (TAPR)** each year to:

- ❑ Pull together a wide range of information on the performance of students in each school and district in Texas every year.
- ❑ Disaggregate student populations in the District and State by student groups, including ethnicity and socioeconomic status.
- ❑ Provide extensive information on school and district staff, finance, programs, and student demographics.

Per Texas Education Code 39, Districts must publish an annual report.

- ❑ State Assessment (STAAR & EOC) for Previous 2 years
- ❑ Attendance Rates
- ❑ Drop Out Rates
- ❑ 4-6 Year Longitudinal for Grades
- ❑ Total Graduates and Graduation Types
- ❑ CCMR
- ❑ AP, SAT/ACT, Dual Credit Completion
- ❑ Total Number of Students
 - ❑ Ethnicity
 - ❑ Economically Disadvantaged
 - ❑ Students with Disabilities
