The 10th Annual JEROME T. CONSIGLIO SCHOLARSHIP

Jerome T. Consiglio has lived his life by the guiding principles of dedication to hard work, pursuit of higher education, devotion to the Catholic faith and commitment to family and country. As a first generation Italian American, Jerome was the first member of the Consiglio family to earn a college degree, graduating with a Bachelor of Science degree in Mechanical Engineering. During World War II, he served three years in the US Army, Ordinance Corps, as a 2nd Lt. The following years of his life found him in a dedicated 45 year government career, raising a family of 5 children, and volunteering as an usher at Our Lady of Good Counsel Church for over 40 years. In honor of Jerome's commitment to his life's principles, his family established this scholarship to award an OLGc parishioner who also embodies these fundamental principles.



The 2020 scholarship will be an award of \$1,000.00. The award is intended for the use of a High School student to cover tuition and/or university provided room and board. Scholarship recipients are eligible for one year of scholarship support. Scholarship monies not used during one academic year are not transferable to the following academic year.

CONDITIONS OF SCHOLARSHIP ELIGIBILITY

To be considered for the Jerome T. Consiglio Scholarship, a student must meet the following criteria:

- Enrolling as a 1st year student in a US accredited institution of higher education for Fall 2020.
- Have a grade-point average of at least 3.0 out of 4.0 (or the equivalent).
- Be a United States citizen or a permanent resident alien.
- Be an established member of the OLGc parish.
- All fields of study are eligible.

APPLICATION REQUIREMENTS AND CHECKLIST

In order to be complete, an application must include the following:

- Completed Student Application. Download application www.JTCscholarship.com
- An official school transcript with 2019/2020 grades as available.
- ACT or SAT scores, or other entrance examination scores as applicable.
- Letter of recommendation/character reference from a teacher or counselor.
- Letter of recommendation from Our Lady of Good Counsel faculty, priest, staff, volunteers or established parishioner.

SELECTION CRITERIA

The JTC scholarship is awarded on the basis of academic performance, field of study, career objectives, and the potential, commitment, and abilities applicants have demonstrated that would enable them to make significant contributions to their chosen field of study. Applications will be "blindly" evaluated. That is, names, addresses and other unique identifiers will not be made available to the scholarship evaluators.

SCHOLARSHIP CONDITIONS OF SELECTED RECIPIENTS

To be eligible to receive payment, the JTC scholar must:

- Submit a written acceptance of the scholarship award.
- Submit a letter of appreciation to Jerome T. Consiglio and Our Lady of Good Counsel parish.
- Submit a color photograph for publication.

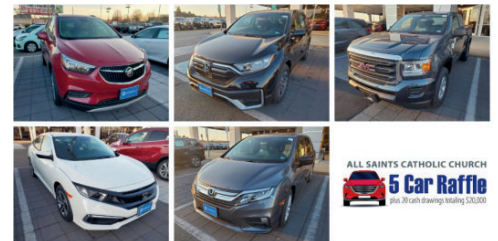

EASTER GREETINGS! May the glory and the promise of this joyous time of year bring peace and happiness to you and those you hold most dear. May Christ, our Risen Savior, always be by your side to bless you and those you love!

SEASONED CITIZENS – The luncheon scheduled for April 23 has been canceled due to the restrictions on such gatherings because of the coronavirus pandemic.

CAREGIVER INFORMATION – If you have someone in your care who tends to wander away from home and become lost or confused due to Alzheimer's disease or other dementia, it may be time to consider enrolling them in the Fairfax Sheriff's Office Project Lifesaver program. Project Lifesaver clients wear a wrist or ankle band that emits a silent tracking signal. When the Sheriff's Office is notified that someone is missing, a search and rescue team, comprised of specially trained sheriff's deputies, responds. Using state-of-the-art locating equipment, they conduct a thorough search. Project Lifesaver has a 100% success rate in locating wandering adults and bringing them safely home. OLD SCAM RETURNS – A scam from the past has returned. It involves a telephone call which is probably recorded, that tells you there's a \$299 charge from Apple on your credit card for computer service and, if you didn't make the charge, you should call a certain number. Do not call the number, because whoever answers will be asking you for personal information in order to reverse the charge, the information you shouldn't be divulging. A parishioner who received one of these calls ignored it but did check with her bank to be sure her credit card didn't reflect this charge. It didn't.

AND WATCH OUT FOR NEW ONES – Scam artists are also taking advantage of the Coronavirus emergency. This includes everything from selling products that supposedly will prevent, treat or cure the virus, such as test kits, supplies, and equipment, to asking for donations to aid people who are sick. If you want to make a donation, make it to the St. Vincent de Paul Society right here at OLCG! What really looking for is your personal information such as a credit card or bank account number, perhaps even your Social Security number, if they tell you they're from "the government" or Medicare. Here are some tips and ways to protect yourself from these specific scams:

- > Ignore any offers, online or otherwise, for coronavirus vaccines, prevention, treatment or cure.
 - > Be wary of an e-mail that claims to be from the U.S. Center for Disease Control or the World Health Organization. Visit these two organizations' websites directly to get the latest information.
 - > Do not click on any links from unknown sources. This could lead to downloading a virus on your computer or phone.
 - > Look out for "investment opportunities" surrounding the coronavirus.
 - > Don't become a victim of price gouging. As a result of Virginia's state of emergency declared earlier, it's unlawful for any supplier to sell, lease or license, or to offer to sell, lease or license, any necessary goods and services at an unconscionable price. You can file a complaint about scams and price gouging to the Virginia Attorney General's Consumer Protection Section: 800-552-9963 M-F from 8:30 am-5:00 pm.
- Another new scam, this time focusing on the U.S. Census, also has arisen. Scammers may pose as census takers to get your personal information and then use it to commit identity theft and other frauds. By now, you should have received the 2020 questionnaire from the U.S. Census Bureau and know that you can respond online, by phone, or by mail. In May census takers will begin visiting homes that haven't responded. Scammers may pose as census takers to get your personal information. Next week you'll read about how to deal with them.

FLU SEASON – With the coronavirus in the news, it's easy to overlook that it's also flu season. The flu impacts older adults, in particular, every year, with 70-85% of season flu-related deaths occurring in people age 65 and older. At this time there is no vaccine for the coronavirus, but it's never too late to get your annual flu shot!

GOOD NEWS – Americans will have an additional three months to file their taxes amid the coronavirus pandemic according to the U.S. Treasury Secretary. The filing deadline for federal income tax returns has been moved from April 15 to July 15, with no interest or penalties. However, The Commonwealth of Virginia has not extended its filing deadline.
