For the 2021 - 2022 school year, schools were identified using new definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has three or more underperforming student subgroups. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school has been labeled a Comprehensive Support and Improvement (CSI) school.

GLVP is a public school accepting any student who is a resident of our school district. We also accept school of choice students from within Kalamazoo County (105) and contiguous counties (105c).

- 7. ADDITIONAL INFORMATION ABOUT OUR SCHOOL AS REQUIRED PER STATE LAW:
  - GLVP currently offers a wide range of Advanced Placement (AP) courses. In the 2020-21 school year, GLVP completed 26 AP courses. Students can earn college credits based on AP Exam results.
  - This number represents less than 11% of all GLVP students eligible to take an AP course.
  - GLVP had 394 students dual enroll at a local college or university over the past two school years. This number represents approximately 62% of the student population.
  - Last school year, GLVP students completed 1188 dual enrollment courses making them eligible to receive college credit. 100% of all GLVP students who dual enroll earn or are eligible to receive college credit.



GLVP provides students with a personalized learning plan and a challenging curriculum in an online setting. The curriculum features courses in Mathematics, Science, Language Arts, Foreign Languages, Social Studies, and other electives. There are opportunities for Advanced Placement and remedial levels as well.
