Objective 1	Create a system of tiered supports for students to minimize social, emotional, and behavioral health barriers to learning after a crisis
Action Step 1	Develop and implement Tier 1 universal supports for all students, including training for families  1. Provide advanced communication, both written and visual (videos), of building, classroom and daily routine changes (e.g., teachers/students wearing masks, classroom set-ups with desks, physical distancing, etc.)  a. Social stories as appropriate  2. Purposefully embed psychoeducation and SEL throughout the year which addresses self-care and self-management skills  a. Activities or evidence-based curriculum  3. Develop scripted lessons addressing school-reentry using the Psychological First Aid (PFA) for Schools: Listen, Protect, Connect  - Model and Teach framework  a. Scripts to be delivered by self-contained and homeroom teachers for first DAY 1 - 5 rotation  b. Scripts will be developmentally appropriate based on ages 5-12; 12-18+; English Learners (ELs), Life Skills Support (LSS), students with disabilities.  i. Reduce initial distress of students by providing education about the event, expected psychological responses and basic coping skills  ii. Facilitate student return and reengagement in learning routines  iii. Educate and denounce potential stigma and microaggressions related to COVID-19 and students and families of Chinese and Asian descent
