# **5** Key Challenges

- 1. **Public health challenge:** The COVID-19 virus has created a number of unknowns around its transmission, its manifestations, and its treatment and cure.
- 2. Lack of agreement: Medical information is continually evolving and there is a lack of agreement leading to disagreement on the appropriate response.
- 3. Lack of time: There is a very short time frame to develop rigorous, well developed plans for reopening schools.
- 4. **Decisions will be scrutinized:** Plans will need to be validated and withstand the scrutiny by all stakeholder groups.
- 5. **Shifting circumstances:** School districts will need to be agile as there may be a resurgence of cases or waves of resurgence. Full or spot closures of schools may be necessary.








- 790 Submitted Responses to an open-ended question

#### 3. How comfortable are you returning to your school/workplace on a normal schedule?



- **199** Submitted Responses to an open-ended question
- Common themes:
  - D155 should follow CDC guidelines/mandates from governing bodies
  - Ready to return to normalcy with awareness of safety protocols
  - A blended style and altered daily schedules preferred to allow smaller class sizes and in-person instruction
  - Teachers require adequate time to prepare for online learning in the fall
  - Social distancing among students in hallways/normal class sizes difficult to achieve and monitor
  - Difficult to police students coming to school when sick/practicing proper hygiene






### **6** Back to School Task Force Teams

### **ISBE** Phase 4 Overview

In-person instruction may resume as regions transition to Phase 4. Districts must follow IDPH guidelines, which provide the following:

- Require use of appropriate personal protective equipment (PPE), including face coverings;
- Prohibit more than 50 individuals from gathering in one space;
- Require social distancing be observed, as much as possible;
- Require that schools conduct symptom screenings and temperature checks or require that individuals self-certify that they are free of symptoms before entering school buildings; and,
- Require an increase in schoolwide cleaning and disinfection.

### **Fall Planning Guiding Principles/Priorities**

- 1. Student/Staff Safety Follow all ISBE, IDPH and CDC guidelines
- 2. Maximize In-person Daily Instruction when possible (Zoom if rotating)
- 3. Maintain a 9 period day to ensure students get the electives they chose during scheduling
- 4. Create a model that allows for the flexibility to move between delivery models quickly (1-day notice)
- 5. Provide daily Social Emotional, Technology and Academic support for staff and students
- 6. Prioritizing daily in-person instruction for special student populations
- 7. Attendance/Engagement is critical (Teachers will be required to engage with students on a daily basis)



# Fall Return to School Plan

# **\*TENTATIVE\***

- A/B structure with 2-3 days per week of in-person instruction with synchronous/asynchronous expectations for students on their at-home days.
- Group A will be in-person on Tuesday/Thursday and every other Monday. Group B will be in-person on Wednesday/Friday and every other Monday.

- Students will be expected to follow their current schedule and be engaged when they are at home.
- Attendance will be taken every day for all students in Skyward.

# **\*TENTATIVE\***

#### • Institute Days

- Monday, August 10 Wednesday, August 12 will be used to support teachers and prepare classrooms for students.
- Training for Safety Guidelines & Expectations and Canvas and streaming tools

#### • Teacher Office Hours

- Teachers will be expected to have office hours during their plan periods and may engage students online during the class period.
- Teachers are NOT expected to engage with students after 4:00 p.m. daily.
- It is suggested that teachers limit contact with students before 7:00 a.m. after 4:00 p.m. in order to take care of yourself and disengage from the technology for a period of time each day.

# Fall Return to School Plan \*TENTATIVE\*

- **Open Campus** for students meeting the building requirements (discipline, grades, and signed parent release form).
  - All students (9-12) are not required to attend 1st or 9th hour Study Hall
  - 11-12th grade students have open campus for all study halls and lunch periods
  - Blended students (grades 11-12) can leave campus on flex periods (all periods)

### **History** of Key Decisions

- Executive Order 2020-05 all public and private schools in Illinois serving Pre-K through 12th grade must close through March 30, 2020.
- Executive Order 2020-10 with exceptions requires all individuals currently living within the State of Illinois to stay at home or at their place of residence. Among other changes, extends mandated statewide school closure through April 7, 2020. March 20, 2020
- Executive Order 2020-33 extends suspension of in-person instruction through end of 2019-20 academic year April 30, 2020
- Executive Order 2020-40 allows for limited in-person instruction, in accordance with IDPH guidance. June 4, 2020
- ISBE releases joint guidance for start of 2020-21 school year June 23, 2020

### **School** Operations

- Public Health
  - Masks ordered and received for all students and faculty
  - Hand sanitizers will be placed in each classroom
  - Spray bottles and paper towels will be available in all classrooms
  - Plexiglass ordering occuring now for point of service areas in schools

• Schools will have "grab and go" options available



### **School Operations**

- Transportation
  - Alternating schedules provide for same bus route utilization
- State/Federal Funding
  - District has applied for and received CARES Act funding (\$320,798)
  - District has applied for FEMA grant funds
- Building Cleaning Process
  - District 155 will allocate an additional daytime custodian during the pandemic

### **ISBE/IDPH Guidance**

- Personal Protective Equipment
  - Masks worn by all (Unless medically contraindicated)
  - Additional PPE available (Face shields, gloves, gowns)
  - Personal water bottles/use of refill stations encouraged vs drinking fountains

### • Cleaning Practices

- Hand sanitizing stations for each classroom
- Cleaning products in classroom (health club approach)
- 1st shift Custodians cleaning vacant classrooms, high contact areas
- Limit the use of manipulatives- individual sets or cleaned after/between use



#### Wellness (Symptom) Screenings required daily

- Parents certify wellness of students before bus/building access- Phone App
- Staff self-certify
- All students and staff temperature check upon arrival in the morning

### School Nurse Efforts (additional nursing/support staff to assist)

- Symptom assessment during the day
- Isolate as necessary (additional space)
- Communicating with parents/health department
- Assist McHenry County Health Department with contact tracing
- Insure compliance with isolation/quarantine requirements before returning to school



### Social Distancing (6 ft)

- A/B allows for <sup>1</sup>/<sub>2</sub> student population in the building/classrooms daily
- Assigned seating on buses
- Sophomores allowed parking privileges as available
- Late Start/Early Release for those with 1st and/or 9th period SHs
- Open campus (Jr/Srs)- relieves congestion
- Breaking larger Study Halls and Lunches into smaller groups/separate areas
- Using our larger spaces differently (Ex. Band/Choir)
- Buildings developing traffic flow plans
- No hallway lockers or locker room usage for PE
- Desk spacing (See images)/assigned classroom seating-face forward, no pods

#### • Substitute needs

- Training 10+ subs to use Canvas this summer
- Recruiting additional subs
- Will likely need "all hands on deck"- teachers, administration
- ID badges required for students/staff
  - Building entry & security
  - Allows scanning vs handling of IDs
- Training/Signage/Announcements/Reminders
- Field Trips and Guest Speakers only in essential circumstances



### **Academics**

- Schedules
  - Traditional, Block, A/B, Remote
  - Ability to adapt throughout the year
- Open Campus
  - Decrease number of students in the building
  - Time for students to have a mask break
- Instruction
  - Maximize face to face instructional time as guidelines/safety allow
    - Aligns with feedback & data from the spring
  - Common Platform Canvas <u>Learning</u> <u>Management</u> <u>System</u>
  - Supports for teachers PD (Canvas, best practices) & Time
  - Large Classes utilizing new/larger spaces, blended approach





### **Academics**

- Curriculum
  - Honor traditional curriculum minor adjustments as needed
  - Return to traditional grading practices
- Assessments
  - Need for flexibility and new approaches
  - In person assessment may be prioritized
- Clear Expectations/Accountability
  - Canvas, Remote Learning, Grading
  - Attendance/Engagement
    - Daily interaction through synchronous streaming and/or asynchronous activities/communication through Canvas

### **IHSA** Phase 4 Return to Play Guidelines

- 20 total contact days
- All students will need physical for participation in fall sports
- There is no "dead week"
- Teams should still follow acclimatization period
- In groups of 50 or less, those groups are to be spaced at least 30 feet apart
- There cannot be any contact drills/physical contact among athletes
- All persons must always wear masks.
- There must be a strict 50 person limit to all indoor activities, and that would include any spectators (people in those groups should also socially distance)
