



Gwynedd Mercy Academy (GMA) is proud to provide extended services for our students through a Children Are Receiving Extended Services (CARES) Program. Our CARES program is designed to provide for a safe and secure environment for students while providing afternoon students with a light snack, outside play (when weather permits), homework time and organized activities. All rules and policies of the school, outlined in the GMA Student-Parent Handbook, apply to CARES.

The morning CARES program will operate from 7:00-8:00 AM. The 2020-2021 pricing per child for the morning CARES program is as follows:

The after-school CARES program will operate from 3:20 PM – 6:00 PM on days when GMA is in full session. For those days when school dismisses early, after-school CARES will not be available.

The 2020-2021 pricing for the after-school CARES program is as follows:

Should you arrive late to pick up your child(ren) from the after CARES program, the following late fees will apply and be expected to be paid upon arrival:

6:00 – 6:15pm	Additional \$5
6:15 – 6:30pm	Additional \$15

For mornings when school is delayed two hours due to inclement weather, CARES will be available on those “late arrival” mornings beginning at 9:00 AM. Also, should school need to close early due to inclement weather, after-school CARES will not be available. On a day with a weather-related early dismissal, your child(ren) will go home per the directions you have specified on your transportation form that is kept in the main school office.

Due to the COVID-19 pandemic situation, we will not offer our “Drop-In” CARES service this school year. So that all students will be familiar and comfortable with CARES safety protocols and procedures, all CARES participants must be formally registered.

GMA does have after-school clubs, activities, and sports programs. Once a child has been dismissed from these after-school activities, they may come to CARES afterwards. The cost per student that utilizes CARES once an activity is finished will be \$10 per day.
