St. Anthony-New Brighton families,

Remaining connected to our families is important to us, especially in this ever-changing situation with the coronavirus (COVID-19) pandemic. Gov. Walz announced today at his daily COVID-19 press conference that he is initiating an Executive Order for Minnesotans to remain safe at home for two weeks, effective Friday, March 27, to Friday, April 10. The top priority of this directive is for the health and safety of all Minnesotans.

Distance learning from March 30 to May 4, 2020:

St. Anthony-New Brighton (SANB) will continue to proceed with our plan to provide distance learning online starting March 30. Per Gov. Walz’s directive, schools are to provide distance learning through at least May 4. We believe this plan will be reevaluated prior to May 4.

I want to emphasize our teachers have developed a structure to ensure your child is supported and educated at a high level in the next few weeks. And we are developing creative opportunities to ensure connections continue between our staff and your child.

We will continue to provide emergency child care at St. Anthony Community Services and will deliver meals and technology to students.

- Meal delivery (breakfast and lunch) information and sign-up form.
- Technology needs information and sign-up form.
- Emergency childcare for tier one and tier two families information and sign-up form.

I want to reiterate, we are ready. We will continue to care deeply for our students, families, and community. We have developed the infrastructure to ensure that our students continue to be supported and receive a high-level of education. In addition, I have immense confidence in our SANB community. The amount of grace and compassion shown by everyone has been amazing. We truly are in this together! We got this! #SANBStrong


