Planning for the Fall

As we finish the school year, I know there are a number of questions about what next fall will look like in School District 197. The decisions for what next fall will look like very much depend on what community health and Minnesota Department of Education guidelines are in place to inform decisions about building access.

While we await direction from the MDE,



School District 197 staff members are hard at work planning for three possible scenarios meet the academic social and emotional

outlined by the MDE and how we can best meet the academic, social, and emotional needs of our students.

The ideas we are considering include:

Traditional learning, similar to a regular school day with precautions based on Center for Disease Control and Prevention (CDC) and Minnesota Department of Health (MDH) guidelines, social distancing and daily cleaning.

Hybrid Instruction, a combination of online learning and some in-person learning. In this scenario, students would attend school in-person part-time in smaller groups, to limit the number of students in a classroom and allow for social distancing. When not at school, students will be expected to complete teacher-assigned work at home.

Continued Distance Learning, similar to what we've been doing this spring but improved upon based on feedback from families and staff, and information we've learned in the past several months. This feedback was gathered through a series of surveys and focus group feedback not only looking back on distance learning in the spring but what families, students, and staff at all levels would like to see should we be distance learning again in the fall.

Additional direction about how we will proceed in the fall will be provided to school districts later this summer.

In addition, we have district teams looking at how the three scenarios would impact food service, cleaning protocols, as well as the different needs of students at the early learning, elementary, middle school, and high school levels. We will continue to provide updates on our planning efforts throughout the summer. These updates will be shared through a variety of communication channels including district and school websites, social media, and email, phone, and text notifications.

Thank you to everyone who has responded to our surveys thus far and/or participated in a focus group. We are fully committed to designing an educational plan that best serves the needs of our students regardless of which scenario is eventually chosen by the Minnesota Department of Education.

To be eligible for bus service, students in grades K-4 must live more than 0.75 of a mile from school, students in grades 5-8 must live more than 1 mile from school, and students in grades 9-12 must live more than 2 miles from school. Pandemic Electronic Benefit Transfer (P-EBT)



Temporary food benefit available to Minnesota families with children who would have received free or reduced-price meals if schools were open.

Families with eligible children will receive a one-time payment of \$325 per child on an existing active EBT card or a newly requested P-EBT card to help fill the gap created by a loss of school meals.

Who is eligible for P-EBT? IF YOU WERE RECEIVING SNAP/EBT ON OR BEFORE March 18, 2020:

Families with eligible children ages 5-18 who were receiving SNAP and/or MFIP on March 18 do not need to apply. A one-time payment was automatically issued to their household's current Minnesota EBT card on May 30, 2020. If you have an inactive EBT card, you must request a P-EBT card.

IF YOU ARE <u>NOT</u> RECEIVING SNAP, OR WERE NOT ON MARCH 18, 2020:

Families who received free or reduced-price school meals in the 2019-2020 school year or attended a school that offers free school meals to all students – but who were not receiving SNAP or MFIP benefits on March 18 – **must complete an online application at** <u>**mn.p-ebt.org**</u> **between June 8, 2020, and June 30, 2020.** Eligible families will receive a Minnesota P-EBT card in the mail within ten days with instructions to activate the card. This card provides access to these one-time P-EBT funds.

P-EBT is NOT SUBJECT to Public Charge rules: EVERYONE who had children receiving free/reduced price meals at school can apply!

The U.S. Department of Agriculture (USDA) has authorized the Minnesota Department of Human Services, the Minnesota Department of Education and Code for America to operate the program.
