





Re-Entry Planning

The Process

Warren-Walker School has established a re-entry task force committee that has been working diligently to develop a strategy that allows for flexibility, transparency, and prioritizes the health and safety of our community. Warren-Walker is currently preparing the physical campuses to support students in the fall of 2020. However, administration recognizes that some families may not be comfortable with their child(ren) returning at that time. As such, our administration has developed two different re-entry options for our families to navigate:

In consult with the CDC guidelines, County of San Diego Health Department, Childcare Licensing, medical professionals and local officials, Warren-Walker is able to execute the physical campus modifications needed to support students safely returning to all campuses in the fall of 2020.



On Campus Learning

Warren-Walker School administration is preparing for an on-campus school operation to resume in the fall of 2020. The community will follow specific health precautions which will be in accordance with our local, state, and federal requirements. Specific decisions and plans regarding on-campus modifications will be finalized over the next few months. However, current considerations can be found on page 6 of this re-entry plan.

Preparing for Interruptions


Following the recommendations from our re-entry task force committee and trends from past pandemics, Warren-Walker school is preparing for waves of interruption to on-campus learning. In the event our local community experiences a spike in COVID-19 cases and an interruption of physical operations occurs, a shift to online learning will happen immediately.



Online Learning

ParentSquare

Google Meet can be joined directly from the daily schedule linked through parent/teacher communication via ParentSquare. This platform is readily enhanced by various Google Tools and Google Classroom.




zoom

Zoom is a video conferencing platform that can be used to provide LIVE, virtual class meeting space, similar to Google Meet. It has many new features that can be added to the remote learning experience.



Physical Campuses

While specific decisions and plans will be finalized over the next several months as more information and updated public health guidelines are issued, strategies are being developed in the following areas, including but not limited to:



Requirements for daily health checks that include a survey & temperature reading for students, faculty, staff and vendors



The use of masks by faculty, staff, and some students (depending on age and new health guidelines)



Institution of classroom capacity limits to allow for physical distancing in all interior and exterior spaces



Sanitizing and cleaning processes



Modification of programs and events in compliance with limits on crowd sizes and physical distancing measures



Changes to campus access for visitors and parents



Continued use of online & virtual platforms in conjunction with in-person services (a “hybrid” approach) to keep in-person contact at safer levels in the areas of academic instruction, student activities, and more



Outdoor learning environments increased & utilized regularly



Most importantly, commitment by the Warren-Walker community to maintain a healthy environment by following risk-mitigation guidelines at school and at home
