Efferens, Charles Batz and Emma Batz, bequeathed to the Town of Ellington 45 acres of rich farmland, known as the "Batz Farm", located at 97 Shenipsit Street, with the stipulation that said acreage is to be allowed to grow wild, with walking trails to be maintained as a nature preserve for educational and conservation purposes for the benefit and enjoyment of the public;
