

## Buñtōn Ko Kōmlet Kaki Nān Onaake & Kōjjeḷā ko Nān Jemān ak Jinen/Ri Lale Ajiri Eo Procedural Safeguards and Parent/Legal Guardian Notices

### MḡWILAḷ IN AN JEMĀN AK JINEN BŌK KWŌŅAAN

- Jemān im jinen ewōr aer jimḡwe nān bōk kwoḡaer ilo kwelḡok ko kōmḡmani nān kakilene, etale, im lale kilaaj ōt eo ri jikuul eo nejer ie im mḡaanjabpopo eo nān juōn jikin jikuul evjelok wōḡāān ilo jikuul ko an kien āinwōt kōmeleleiki ilo Individualized Education Program (IEP) (Pirokiraam eo an Kajjojo Ri Jikuul). Ri jermal ro ilo jikuul eo remaroñ kōmḡmani kwelok ko redik ijo ejako ro jemān im jinen.
- Juōn ekkatak kōmḡmane kajjojo iiō kōn jermal ko an *special education* kōn buñtōn *Individualized Education Program (IEP)* eo.
- Jemān im jinen ewōr aer jimḡwe nān bōk ilo iien ko rekkar melele ko kōn eddōḷḷok eo an ajiri eo nejer nān kōttōppar ko an Individualized Education Program (IEP) (Pirokiraam eo an Kajjojo Ri Jikuul) eo ilo ejja kōtaan ko wōt me jikuul eo ej kadieojḷok ripoot card ko an aolep ri jikuul.

### LḲḲ KO AN JIKUUL IM TILJEK IN MELELE

- Jemān im jinen remaroñ lali lḲḲ ko an ajiri eo nnjier ilo *special education*. LḲḲ kein rej lak ilo juōn *file* ejenolok jān lḲḲ ko jet an jikuul. LḲḲ kein rej jab walḡok ñe ejjelok mālim jān jemān im jinen nān wōt ri jermal ro an tijtirik im ewōr aer eddo ilo an ri jikuul eo jikuul.
- Ewōr an jemān im jinen jimḡwe nān kajjitōb bwe melele ko ilo lḲḲ ko an ajiri eo nejer en wōr kakkobaba nān i elaññe rej tōmak ke ejjab jimḡwe ak ejjab ḡool.
- Ñe kajjitōki, Galen ko in lḲḲ kein naaj kōmḡman nān jemān im jinen ilo juōn tōrean iien eo ekkar.

### KŌMĀLIM

- Jemān im jinen reaikuuj errā, ilo jeje, mokta jān etale eo jinointata im aer likiti ajiri eo nejer ej *special education* ilo kilaaj.
- Mālim in jān jemān im jinen aer wōt pepe im remaroñ jolok e jabdewōt iien.
- IEj *policy* eo an Utah State Office of Education (USBE) (Opij eo an Jikin Jeḷāḷḡkijen an Bukwōn in Utah) nān jilkinḷok lḲḲ ko an juōn ri jikuul ilo ejjelḡok mālim jān jemān im jinen ak kōjjeḷā nān opija ro an bar juōn jikuul ak jikuul tijtirik eo me ri jikuul eo ej pukōt an deloñe.

## ETALE WĀWEEN JIKUUL EJENOLOK (INDEPENDENT EDUCATIONAL EVALUATION)

- Jemān im jinen remaroñ kajjitōk juōn etale ejenolok jān jikuul kōn ri jikuul eo nejer elaññe rej jab errā ilo aolepān an mōttan ekkatak eo team jān jikuul eo e kar kōmḡmane. Ri kaki eo an special education emaroñ jilkinlōk jemān im jinen ñan *tijtirik special education director* (director eo an special education ilo tijtirik) eo ñan ekkonono kake kajjitōk eo im buñtōn onaake ko.

### KAJE

- Jimḡwe ko an ri jikuul ro ewōr jipikpik ko ippāer, ikkijien kaje, rej ekkar liktak ippān policy in onaakenko an Davis School District (DSD) (Davis Jikuul Tijtirik). Tipdik in kakjojo melele maroñ loi ilo *Buñtōn Okaanke Ko Ñan Ajiri* ro Ewōr Jipikpik l'Ānbwinier im Ro Jemāer im Jineer bok jidikdik eo.
- Ri jikuul ro ewōr aer jimḡwe ñan jipañ ko (*services*) rej iieoklōk wōt eddōklōk eo ejjet ilo *general education* im kōttōppar ko an IEP eo elaññe kōmakit e jān jikuul kōn elōñlōk jān joñoul raan in jikuul ilo uwaake makitkit in kaje ko.

### BUÑTŌN ABÑŌÑŌ

- Davis School District (DSD) (Davis Jikuul Tijtirik) ekōñaan kanuij lale bwe ñurbōktak ko an jemān im jinen ren mejal kōn *special education pirokiraam* eo ñan ajiri eo nejer. Ñurbōktak ko an jemān im jinen rej mejali ilo aer kōjberbal lamlam in wōnḡmaanlōk in:
  1. Kwelok an IEP team eo
  2. Principal an Jikuul In
  3. Tijtirik Special Education Supervisor
  4. Director eo an special education ilo tijtirik
  5. Tijtirik Superintendent (Eo Jeban Jikuul Tijtirik)
  6. USBE (Opij eo an Jikin Jeļāļokijien an Bukwōn in Utah) – Special Education Services (SES)
- Elaññe juōn ñurbōktak ejjab mejal, im jemān im jinen rej eñjake ke Tijtirik eaar kajejtokjān men ko Individuals with Disabilities Education Act, (IDEA) ej ba, (Kakien eo kōn Armej ro Ewōr Jipikpik l'ānbwinnier) ej ba kōmḡmani im rekōñaan kōmmāne juōn *formal* abñōñō ilo jeje, abñōñō in rej aikuuj bōklōk ñan Tijtirik Superintendent eo ak State Director eo an Special Education lumin USBE Office (Opij eo an Jikin Jeļāļokijien an Bukwōn in Utah), eo me enaaj etale ak jitōñe bar juōn ñan etale abñōñō eo.
- Elaññe tijtirik ejjab maroñ mejale tōrāre in melele eo, juōn buñtōn kōmḡman aenōmḡman naaj jakemāantak. Elaññe buñtōn kōmḡman aenōmḡman in ejjeļok tōprak in, rein jemān im jinen remaroñ kajjitōk juōn iien roñjake (*due process hearing*). *Kajjitōk in* ej aikuuj kōmḡman ilo jeje ñan *Superintendent* (Ej Jeban Jikuul Tijtirik) eo.

### JIKUUL EO EJJAB AN KIEN (*PRIVATE SCHOOL*)

- Davis School District (DSD) (Davis Jikuul Tijtirik) ej aikuuj kōjeļāik jemān im jinen bwe juōn jāān in jikuul (*scholarship*) ñan deloñe juōn jikuul ejjab an kien epoojak ñan juōn ri jikuul eo ewōr jipikpik ko i'ānbwinnin kōn Carson Smith Scholarship Pirokiraam eo.
