Special Flood Hazard Area Zone:

This project is to restore the Hatteras Secondary School's gym, media center, and hallways back to pre-disaster function within the existing footprint. All work is located in an AE zone (1% Annual Chance Flood Hazard). Confirmation of location in a Special Flood Hazard Area (SFHA) was determined by the Dare County Preliminary Flood Insurance Rate Map, Panel Number: 3730052600K, dated 06/30/2016. The proposed work conforms to all applicable State of North Carolina and local floodplain regulations. There is a potential for the facility to be impacted by future flooding events due to its location within the AE zone. The proposed work will not take place in wetlands per the United States Fish and Wildlife Service National Wetlands Inventory and will have little potential to impact or affect wetland values.

Proposed Work and Purpose:

Dare County Schools is restoring the Hatteras Secondary School's gym, media center, and hallways. To minimize future flood damages, improvements included installing an aluminum metal roof and epoxy floor. These repairs will restore the building's longevity and functionality

for the educational use by the community.

Project Alternatives:

Alternative #1 (No action): The 'no action' alternative would ultimately result in the building being unsafe, an adverse social impact to Dare County, as the facility provides a vital educational service

to the community.

Alternative #2 (Repair in Kind): Repairing in kind without minimization measures is not practicable as similar flood damages could occur in the future. If similar damages occur, it would

cause adverse social impacts by disrupting educational services in the community.
