

School Reopening Plan September 2020

Presented to the Board of Education August 6, 2020

Background Information

- Governor Cuomo has previously indicated that schools would be open if the 14-day rolling average of new positive tests remains below 5%. This information can be viewed on the *Early Warning Monitoring Dashboard*.
- Be wary of comparing school models--each model is heavily influenced by local factors.
- Governor Cuomo is expected to make an announcement tomorrow; this announcement may significantly influence our planning.



Background Information

- Schools received guidance on reopening from the New York State Education Department on July 16, 2020.
- Haldane's School Reopening Task Force met over a three week period to develop its school reopening plan.
- Plan requirements included 89 separate assurances to which schools must attest in order to reopen.
- Haldane's plan was submitted last week and is posted on the District's website.

Guiding Principles

- Our reopening plan prioritizes the *health and safety* of students and staff who return to campus.
- Our plan maintains *instructional continuity* across three scenarios: Remote learning; In-Person instruction, and a Hybrid of remote and in-person instruction.
- Our plan highlights our District's *ability to adapt* to a variety of scenarios that we may encounter through the school year.





Academic Model

Elementary and Middle Schools In-Person Learning Model

- All K-8 students will attend classes on campus every day
- The first day of school may vary by grade as we re-introduce students to campus with a "phase-in" approach through the first week of school
- When possible, teachers will transition between classes rather than students to reduce hallway congestion and frequency
- If elementary enrollment increases, Teaching Assistants will provide academic support and help maintain reduced classroom numbers



Elementary and Middle Schools In-Person Learning Model

- Shared physical resources will be eliminated or reduced & sanitized to the extent possible
- Teachers will make all students familiar with virtual resources and procedures in the event of transition to a Hybrid or Remote Learning Model
- Grades 6-8: Google Classroom will be used communicate expectations and assignments; PowerSchool will be used to track grades and attendance
- Virtual accommodations will be determined for families who opt out of in-person attendance



High School Hybrid Learning Model

- High school students will be divided into two cohorts alphabetically, rotating between attending classes on campus and participating virtually
 - Example: Monday & Tuesday Cohort 1 in-person, Cohort 2 at home;
 Wednesday & Thursday Cohort 2 in-person, Cohort 1 at home
 - On a continuous 2-day rotation
- In-person and remote cohorts follow the same rotating schedule each day to ensure continuity of learning
 - Direct instruction/mini-lessons will be screencasted, not entire period
- Faculty will teach on campus every day as cohorts rotate



High School Hybrid Learning Model

- Emphasis on electronic textbooks and assignment submission
- Google Classroom will be used to communicate expectations and assignments; PowerSchool will be used to track grades and attendance
- The first day of in-person school may vary by grade as we re-introduce students to campus with a "phase-in" approach through the first week of school
- Virtual accommodations will be determined for families who opt out of in-person attendance



Specials

- Special Area teachers will be encouraged to hold classes outdoors when space and weather allow
- When indoors, Elementary Special Area teachers will travel to classrooms to meet with students (tentative)





Alternate Spaces

On-Campus Outdoor Space

- Outdoor areas will be marked for class use
- Faculty will be encouraged to take advantage of outdoor classrooms as appropriate, based on course needs and weather constraints
- A rotating schedule or reservation system will be used to allow all grade levels spend time outdoors during the school day
- Physical Education and Music/Chorus will be held outside when possible



Off-Campus Space Utilization

- September reopening plan does not utilize a remote campus
- Administrative team continues to explore viability of local facilities should greater social distancing become necessary
- Evaluating ability to host several grade levels in one location for efficiencies in transportation, food service, and mandated services
- Locations must comply with all New York State Office of Facility Planning regulations and code requirements for schools





Health & Safety

Health Screenings

- Parents/guardians must complete daily, online assurance of family's health status (temp below 100°F, symptom-free, no confirmed exposure)
 - Based on current guidelines, the school nurses will be required to check the temperatures of each student for whom a daily assurance is not submitted
- Faculty and staff will also be required to complete the daily assurance
- School nurses will conduct random temperature checks of faculty, staff, and students to ensure reliability of self reporting



PPE & Hygiene

- Masks will be required for all faculty, staff, and students when 6 ft of distance cannot be maintained (with allowances for medical exceptions)
- NYS-provided hand sanitizer, masks, gloves and other PPE will be made available on campus
- Handwashing and respiratory hygiene will be reviewed with faculty, staff, and students and reinforced with signage throughout buildings



Social Distancing

- Classrooms will be marked to ensure 6 ft of social distancing
- Hallways and common areas will be labeled for distancing and traffic patterns
- Students will eat lunch in their classrooms
 - Brown bag lunches will be available for pre-order and will be delivered to classrooms
- Recess will be spaced throughout the day for greater distancing

16 desks per classroom allows 6 ft between students and a minimum of 6 ft for teacher at front of room



Transportation

- Routes will be developed for more equal distribution of students
- Masks will be required for those medically able
- Buses will be disinfected between AM and PM runs; a more thorough disinfection will occur each night
- Alternate transportation will continue based on Individual Education Plans (IEPs)
