

## The Agnes Irwin Community Agreement

## PROTECTING MYSELF | PROTECTING OTHERS | PROTECTING OUR SCHOOL COMMUNITY

Being a member of The Agnes Irwin School community means that we each must take necessary steps to stay well and protect each other, on campus and beyond. To maintain health and safety at school, and to minimize the risk of spread, it is critical that we are accountable to each other, knowing that our individual choices affect our community as a whole.

Community is a Core Value at Agnes Irwin and as such, we expect all those who are a part of our school to agree to take responsibility for their own health, for the protection of others, and for the collective wellbeing of the AIS community, working in partnership to help keep us safe from the spread of COVID-19.

## As a student at Agnes Irwin, I agree to...

- Monitor myself daily for symptoms of COVID-19 and complete my symptom screening honestly, doing so by 7:30 a.m. each day.
- Honor the results of my symptom screening and stay home if I am feeling sick in any way.
- Immediately visit the nurse if I begin feeling ill while on campus.
- Communicate honestly and in a timely manner with the school about any possible exposure to an individual with suspected or known COVID-19.
- Wash my hands often during the day with soap and water for at least 20 seconds and use hand sanitizer when handwashing is not possible.
- Wear a mask at all times when I leave my home and when I am on campus, unless told otherwise by a supervising adult.
- · Follow all written, posted and verbal instructions on campus regarding social distancing and on-campus safety.
- Keep my personal belongings and all school supplies clean and refrain from sharing with anyone for any reason.
- Practice personal safety and social distancing when off campus as well, refraining from attending off-campus social
  gatherings that may create risk for me, my family, and others in the AIS community, and minimizing unnecessary travel
  as much as possible.
- Ask for help from a trusted adult if I am feeling anxious or overwhelmed with the new protocols at school.
- Uphold our core values of community, character, and respect in my interactions with others by showing empathy and compassion, honoring the privacy of fellow students and their families, practicing inclusivity, kindness, and respect, and supporting others as they face the challenges of COVID-19, even if those experiences are different from my own.

## As a parent/guardian at Agnes Irwin, I agree to...

- Monitor my child daily for symptoms of COVID-19 and complete the symptom screening honestly, doing so by 7:30 a.m. each day.
- Honor the results of my child's screening and keep them home if they are feeling sick in any way.
- Follow the Department of Health, pediatrician, and school guidelines for re-entry to school if my child has to stay home for any reason.

- Communicate honestly and in a timely manner with the school about any possible exposure to an individual with suspected or known COVID-19, and keep my child at home if they may have been exposed.
- Ensure my child has a solid-colored face mask to wear each day for school.
- Help my child(ren) understand the importance of and reason behind new safety precautions at school. Communicate with the school if my child is having difficulty understanding the safety protocols which have been established.
- Review safety protocols regarding social distancing, hygiene practices, mask wearing, and care for personal belongings with my child in advance of the school year and on a regular basis while school is in session.
- Help my child practice personal safety and social distancing when off campus as well, by refraining from attending
  off-campus social gatherings that may create risk in the AIS community, and minimizing unnecessary travel as much
  as possible.
- Keep up to date with, and adhere to, Pennsylvania Department of Health recommendations around post-travel quarantine. I understand this means my daughter must quarantine for 14 days upon return from states designated as high-risk by the Pennsylvania Department of Health.
- Uphold our core values of community, character, and respect in my interactions with others by showing empathy and compassion, honoring the privacy of students and their families, practicing inclusivity, kindness, and respect, and supporting others as they face the challenges of COVID-19, even if those experiences are different from my own.

I understand that The Agnes Irwin School campus will be closed to visitors while students are on campus, including parents/guardians (with the exception of extenuating circumstances), for the 2020-2021 school year.

I also agree to adhere to Agnes Irwin's requirement of a two-week quarantine in advance of the school year, minimizing the potential for exposure on campus when we open this fall. This means being diligent about mask use, social distancing, and hygiene practices, and refraining from attending social gatherings that may create risk in the AIS community, as defined by CDC guidelines. I understand that beginning August 25 and until notified otherwise, Agnes Irwin community members must quarantine for 14 days upon return from states designated as high-risk by the Pennsylvania Department of Health. I understand that this will mean beginning the school year remotely if returning from a high-risk state on August 25 or later.
