If you are 60 years of age or older or disabled and your income is limited but more than the amounts listed, you may be able to get benefits from the Supplemental Nutrition Assistance Program. Contact your county human services office or call 888-711-1151.

If enrolled in the Supplemental Nutrition Assistance Program, you also qualify for a telephone discount through the Lifeline and/or the Telephone Assistance Plan. Contact your local telephone company to apply.
