

Challenger Athletics Player Contract

PROGRAM MISSION and BELIEFS:

- To provide a well-designed and directed extra- and co-curricular activity
- To encourage school spirit and pride in CHS
- To promote physical, social, and mental development
- To develop leadership, cooperation, sportsmanship, and collaboration skills
- To represent the school to the highest level
- To set an example of good behavior and sportsmanship at all times, wither in uniform or not
- To promote friendship with each other and with schools with whom we compete

CODE of Ethics:

- Ensure equal opportunities to all students without regard to gender, race, religious creed, color, national origin, ancestry or economic capability
- Emphasize the ideals of sportsmanship, ethical conduct, integrity, accountability, and fair play
- Abide by all school, district, and conference rules
- Show courtesy to all visiting teams, competitors, hosts, and officials
- Respect the integrity and judgment of all competition officials

ELIGIBILITY:

- Must be enrolled at CHS
- Must be under 19 years of age, on or before August 1
- Must pass 75% of classes from previous semester and be promoted to the next grade level
- Must maintain an overall GPA of 2.0 and/or a High School GPA of 2.5 and/or a college GPA of 2.0
- Must maintain passing average in each class during the season; teachers, coaches, AD can hold students from practice AND games if students are in jeopardy of failing
- All members must have a physical, signed contract, concussion form, pledge, acknowledgement on file with the athletic department BEFORE practices begin
- All practices, camps, and games are mandatory
- Equipment cost paid in full; players keep personal equipment

CONDUCT

- Promoting good sportsmanship by way of example is required at all times. Members must NOT use foul language at practices, in school, at games, camp, or competitions, etc.
- Any excessive display of affections is not allowed in uniform, at games, or in the school setting.
- Proper appearance is required at all times, with clothing appropriate to the occasion.
 Dress for success on ALL game days.

- Exemplary behavior is mandatory at all times, anywhere in the community and at all school functions where you are a representative of CHALLENGER.
- If a member is removed from or chooses to quit the team, he/she is still responsible for payment of all items ordered and CANNOT attend the sports banquet.

Disciplinary action may result from the following:

- a. Tardiness
- b. Wearing jewelry (ALL JEWELRY IS INCLUDED, NO EXCEPTIONS!!!)
- c. Using profanity while in uniform
- d. Untidy uniform
- e. Talking to fans or parents excessively during games, competitions, etc.
- f. Not being with the team during the game, competitions, etc.
- g. Display of unsportsmanlike conduct
- h. Uncooperative attitude
- i. Eating or drinking on the floor/field during games and/or practices
- j. Absent from games, practices, or other team relations function
- k. Cell phone use

EQUIPMENT COST

- Team members are responsible for equipment/apparel costs.
- Coach determines equipment and apparel needs and the ordering procedure.

PARENT SUPPORT and AGREEMENTS

- Recognize that coaches determine playing time based on a wide range of information
- Participation on the team is just as important as playing time
- Approaching the coach before, during, or after a game is PROHIBITED. The 24-hour rule MUST be followed. Parents will wait 24 hours to voice concerns, questions, issues to the coach and/or athletic director.
