- ___ 7. Currently or in the preceding school year in a residential placement facility in the district, including a detention facility, substance abuse treatment facility, emergency shelter, psychiatric hospital, halfway house, or foster group home;
- ___ 8. Pregnant or is a parent;
- ___ 9. Campus based or off campus alternative education program (Section 37.006-Action Code 07: Discipline Code 02,04,05,06,07,08,09,10,26,28, 49) on or during the preceding or current school year;
- ___ 10. Expelled in accordance with Section 37.007 (Action Code 02: Discipline Code: 04,05,11,12,13,14, 16,17,18,19,22,27,29,30,31,32,46,47,48) during the preceding or current school year;
- ___ 11. On parole, probation, deferred prosecution, or other conditional release;
- ___ 12. Limited English Proficient;
- ___ 13. In the custody/care of the Department of Protective and Regulatory Services or has, during the current school year, been referred by a school official, officer of the juvenile court, or law enforcement official.
