

# DAVIS SCHOOL DISTRICT HOME RELEASE CONTRACT

Students who will be on track for graduation or who may have more than the required 27 credits may choose to register for a Home Release/NO CREDIT course. The following serves as a guideline, a disclosure to students and parents, and a contract between parents, students, and the school.

Failure to comply with the guidelines may result in a loss of Citizenship Credit and repeated non-compliance may result in disallowing Graduation because of a loss of citizenship credit.

Please review checklist of requirements with Parent/Guardian and Student:

- ✓ Students are to be informed of their graduation status at the time they register for Home Release.
- ✓ The student and parent/guardian are aware that the Home Release is for NO Credit.
- ✓ The parent/guardian of the student takes full responsibility for the student's conduct, safety, transportation, and location during Home Release periods. Davis School District is released from this responsibility during Home Release periods.
- ✓ Students may not be on the campus of any Davis School during the periods for which they are registered for Home Release unless they are on official school approved business. This is to reduce distracting of other classes and students.
- ✓ Students **agree** that if they *are* on the campus during their Home Release time, they may be given an "Administrative "U" citizenship grade on the first occurrence. Repeated violation of this may result in trespassing citations and the student being denied participation at the regular graduation exercises.
- ✓ It is recommended that students register for Home Release at the end of and/ or the beginning of the day so that students will not have to come to school, leave school, and then return again during the same day.

## DSD LAYTON HIGH SCHOOL HOME RELEASE CONTRACT



**STUDENTS & PARENTS, PLEASE READ BOTH SIDE CAREFULLY BEFORE  
AGREEING TO DISTRICT AND SCHOOL GUIDELINES FOR HOME RELEASE.**

This informational agreement must be signed by both parent and student before permission will be granted for an abbreviated schedule.

***Home Release periods may prevent:***

- Honors status at graduation. Students must be enrolled in 7 classes for 10<sup>th</sup> & 11<sup>th</sup> grades of high school as one of the requirements for Honors at graduation.
- Qualification for perfect attendance award.
- XLR8 recognition (increase of .5 GPA). Students must be enrolled in 7 class periods during each term.
- College Acceptance. Many colleges and universities expect a full, rigorous schedule during the entire senior year.
- Graduation from Layton High School. Home Release has no credit attached and may prevent a student from reaching the 27 credits needed to graduate.
