Unemployment Benefits

Individuals unemployed due to COVID-19 are encouraged to apply for unemployment benefits, even if they would not normally be eligible. Eligibility will be determined on a case-by-case basis. Don't have access to file a claim online? Can a family member, friend, or neighbor help? If not, call our office for assistance.

Emergency Financial Assistance

Individuals struggling financially with food, fuel, or other emergency expenses should contact our office so we can determine eligibility for one time emergency assistance or for any state or federal benefits and programs. Documentation is required in order to establish eligibility.

Health Insurance

You can contact the CT Department of Social Services 855-626-6632 or <u>www.connect.ct.gov</u> regarding applying for HUSKY A, B, C or D. This includes the Medicare Savings Program (MSP) and Long Term Care Services.

Rental Assistance

As of March 20, all eviction orders have been suspended through May 1. This means that a State Marshal cannot serve an individual with an execution eviction order, physically remove them or their belongings from the apartment, or change the locks before May 1st. Landlords can still serve tenants with court papers and file a new eviction case, but the court is not holding hearings or trials right now, until further notice.

Foreclosures & Mortgage Assistance

All foreclosure sales previously scheduled to have occurred in Connecticut in April or May are rescheduled to June 6th, 2020. Homeowners who have been laid off or have lost income/work hours should contact their mortgage company about getting a forbearance on their mortgage. Single family homeowners with Fannie Mae or Freddie Mac have a 60-day stay on foreclosures and evictions. Multi-family property owners with mortgages through Fannie Mae or Freddie Mac will be granted a 60-day forbearance with the condition that they suspend all evictions for renters unable to pay rent. Additionally, as of March 18, single-family homeowners in need of additional mortgage counseling and assistance can visit <u>211ct.org</u>

<u>Shelter</u>

If you are in need of shelter, please dial 2-1-1 or go to <u>https://www.211ct.org/</u>. 2-1-1 will direct you to the nearest shelter that has an available bed.

Utility Assistance

Connecticut's Public Utilities Regulatory Authority (PURA) has ordered a moratorium on all utility shut-offs (electric, gas, and water) for the next 30 days, or as long as the Public Health and Civil Preparedness Emergency is in effect. Customers are strongly encouraged to continue paying their bills, as they will ultimately be responsible for accrued services. This ruling applies to all residential customers and is therefore unlike the Winter Protection Program where income protected households are protected from shut off through May 1st.

Ellington Public Schools - Grab and Go Pantry - Ellington Public Schools is offering a grab & go breakfast and lunch at Ellington High School between 7:30am – 9:00am and 11:30am – 1:00pm. All children from families in need are eligible to receive a free meal, as long as they are under 18 and one child attends the Ellington Public Schools. In addition, a temporary food bank is available during the grab & go service hours to assist those families.

Grocery stores have set up special hours for seniors and some are offering curbside pick-up. Use local delivery services and/or grab-n-go situations when possible (Local grocery stores are offering deliveries and/or try Insta-cart or Amazon Prime.) Pharmacies/Prescriptions

It is recommended that you obtain extra medication to have on hand during the COVID-19 outbreak. Please consider using mail-order during this time, if your insurance company allows.

Additionally, pharmacies such as CVS, Walgreens, Big Y, Stop and Shop, etc. may be offering free delivery of prescriptions. Please contact your pharmacy directly for more information.

Transportation

HVCC (Hockanum Valley Community Council) Dial a Ride is providing rides to anyone 60 years or older to the grocery store between 6:30am and 8:00 am. They also provide medical and other transportation. **Call 860-870-7940 for more information.**

<u>Taxes</u>

The Deadline to file and pay both federal and CT State income taxes has been extended until July 15th. Please visit <u>irs.gov/coronavirus</u> and <u>portal.ct.gov/DRS/COVID19/DRS-COVID-19-Response-FAQ</u> for up to date information.

Currently VITA sites are closed until further notice. Visit IRS.gov for a variety of online resources and tax help including tax forms, instructions and publications, online payment options and to file with <u>IRS Free File</u> – free for most taxpayers.

Financial Assistance for Small Businesses

Connecticut Recovery Bridge Loan Program: Connecticut businesses with less than 100 employees impacted by COVID-19 may apply for a one-year, no-interest loan of up to \$75,000 through the Department of Economic and Community Development (DECD).

Federal Disaster Assistance Loans: The U.S. Small Business Administration (SBA) is offering low-interest federal disaster loans to small businesses suffering substantial economic injury as a result of the Coronavirus (COVID-19). These loans may be used to pay fixed debts, payroll, accounts payable, and other bills that can't be paid because of the disaster's impact. The interest rate is 3.75% for small businesses without credit available elsewhere; businesses with credit available elsewhere are not eligible. The interest rate for non-profits is 2.75%. SBA offers loans with long-term repayments in order to keep payments affordable. Terms are determined on a case-by-case basis.
