With your permission, and if your child is deemed eligible for free or reduced lunch, your child's status will be provided to a select group of NFA faculty for this reason only, while strictly adhering to and maintaining confidentiality. If you choose to participate, please complete the Information Sharing Agreement.

NORWICH FREE ACADEMY FOOD SERVICE PROGRAM – CHARGING POLICY 2020-2021 SCHOOL YEAR

It is the collective position of Norwich Free Academy and Chartwells Dining Services that NFA students will have the necessary nutrition to remain focused during the school day. To that end, we have agreed upon the following charging policy for the 2020-2021 academic year.

- NFA students may charge breakfast and lunch up to \$10. The afterschool snack is provided to any student free of charge.
- Throughout the year if and when a student owes \$10 or more in meal charges, the account will be considered delinquent. Parents/guardians will receive a letter informing them of the amount owed.
 - The outstanding balance may be paid in cash with a Chartwell's cashier during the daily lunch period or by using our on-line payment system, MySchoolBucks. Access MySchoolBucks at MyNFA>Parents on the NFA website, www.nfaschool.org.
 - Parents are encouraged to apply for Free and Reduced price school meals by visiting MyNFA>Parents>Chartwells Food Service on the NFA website, www.nfaschool.org.
- At the conclusion of the school year, delinquent food service accounts will be handled in the same manner as other unmet student financial obligations (e.g. missing/lost textbooks, uniforms, school issued equipment, etc.).
 - NFA will notify the student and his/her parents/guardians in writing of the food service debt.
 - Parents should make checks payable to Norwich Free Academy and have their child bring the check and the letter you received to the cafeteria.
 - o The cafeteria will validate the debt as paid by stamping the letter "Received".
 - o The student will bring the validated letter to the Director of Student Affairs, who will then clear the debt.
- The NFA Administration and Chartwell Dining Services Management will re-evaluate this charging policy at the conclusion of the 2020-2021 academic year.

NFA Procedure for Handling Child Nutrition Civil Rights Complaints:

If a parent feels that they or their child has been discriminated against, they must file a written complaint to the Hearing Officer stating the reason for and details of the complaint. After the complainant's information has been reviewed, the Hearing Officer will respond via letter as to whether or not the complaint is substantiated or unsubstantiated. If documentation or other information is necessary, they will be asked to provide it. Upon receipt, the Hearing Officer will contact the parent to schedule a mutually agreed upon meeting to further discuss the complaint and to present the final ruling.

Frequently Asked Questions (FAQs) About Free and Reduced-price School Meals

Dear Parent/Guardian:

Children need healthy meals to learn. Norwich Free Academy offers healthy meals every school day. Breakfast costs \$ 2.00 and lunch costs \$ 3.00. Your children may qualify for either free meals or reduced-price meals. The reduced price is \$.30 for breakfast and \$.40 for lunch. This packet includes an application for free and reduced-price meal benefits and detailed instructions.

NOTE: Children receiving Supplemental Nutrition Assistance Program (SNAP), Temporary Family Assistance (TFA) or Medicaid (HUSKY) benefits *may* be directly certified and automatically eligible for free meals without applying for benefits. (Some children who receive Medicaid (HUSKY) benefits **may** also be directly certified and automatically eligible for *reduced-price* meals.) Questions regarding SNAP/TFA/Medicaid and direct certification should be sent to the determining official, **Colleen DeClerck**, **860.425.5521**.

If you have received a NOTICE OF DIRECT CERTIFICATION for free or reduced-price meals, **do not** complete the application unless instructed to do so by the district. Let the school know if any children in your household are **not** listed on the **Notice of Direct Certification** letter you received, since free or reduced meal benefits are extended to all children in a household when directly certified.

Additionally, all school-aged children in income-eligible households can receive school meal benefits regardless of a child's immigration status and the district/school does not release information for immigration-related purposes in the usual course of operating the Child Nutrition Programs.

The **Norwich Free Academy** complies with the federal requirements for meal modifications for children with special dietary needs. The requirements for meal modifications are different for children with and without disabilities. For more information, please contact the food service director, George Crowley at **860.425.5686**.

The answers to the common questions below can help you with the application process.

1. Who can get free or reduced-price meals?

- All children in households receiving SNAP or TFA benefits are eligible for free meals. Note: *Some* students receiving Medicaid (HUSKY) benefits are eligible for free or reduced-price meals.
- Foster children that are under the **legal** responsibility of a foster care agency or court are eligible for free meals. (Note: A foster child is categorically eligible for free meals and may be included as a member of the foster family if the foster family chooses to also apply for benefits for other children. Including children in foster care as household members may help other children in the household qualify for benefits. If non-foster children in a foster family are not eligible for free or reduced price meal benefits, an eligible foster child will still receive free benefits.)
- Children participating in their school's Head Start program are eligible for free meals.
- Children who meet the definition of homeless or runaway are eligible for free meals.
- Children may receive free or reduced-price meals if your household's income is within the limits
 of the Federal Income Eligibility Guidelines. Your children may qualify for free or reduced-price
 meals if your household income falls at or below the limits on this chart:

- 2. **How do I know if my children qualify as homeless or runaway?** Do the members of your household lack a permanent address? Are you staying together in a shelter, hotel, or other temporary housing arrangement? Does your family relocate on a seasonal basis? Are any children living with you who have chosen to leave their prior family or household? If you believe children in your household meet these descriptions and you have not been told your children will get free meals, please call or e-mail **Joanne Zenowitz**, **860.425.563**9.
- 3. Do I need to fill out an application for each child? Only if one of the students attends NFA (You are required to complete an application for students attending Norwich Free Academy. If siblings attend school in a partner district, you are required to complete an application for that district as well. This includes Norwich Public Schools). We cannot approve an application that is not complete, so be sure to fill out all required information. - 4. Should I fill out an application if I received a letter this school year saying my children are already approved for free or reduced-price meals? No, but please read the letter carefully and follow the instructions. If any children in your household were missing from your eligibility notification, contact Colleen DeClerck, 305 Broadway, Norwich CT 06360. 860.425.5521, declerck@nfaschool.org immediately.
- 5. **Can I apply online?** Not at this time.

FAQs About Free and Reduced-price School Meals

- 6. My child's application was approved last year. Do I need to fill out a new one? Yes. Your child's application is only good for that school year and for up to 30 operating days into the new school year (or until a new eligibility determination is made, whichever comes first). When the carryover period ends, unless you are notified that your children are directly certified or you submit an application that is approved, your children's meals must be claimed at the paid rate. Though encouraged to do so, the LEA is not required to send a reminder or a notice of expired eligibility.
- 7. **I get WIC. Can my children get free meals?** Children in households participating in WIC **may** be eligible for free or reduced-price meals. Please send in an application.
- 8. **Will the information I give be checked?** Yes. We may also ask you to send written proof of the household income you report.
- 9. **If I don't qualify now, may I apply later?** Yes, you may apply at any time during the school year. For example, children with a parent or guardian who becomes unemployed may become eligible for free and reduced-price meals if the household income drops below the income limit.

What if I disagree with the school's decision about my application? You should talk to school officials. You also may ask for a hearing by calling or writing John Iovino, 860.425.5510, iovinoj@nfaschool.org.

- 10. **May I apply if someone in my household is not a U.S. citizen?** Yes. You, your children or other household members do not have to be U.S. citizens to apply for free or reduced-price meals.
- 11. What if my income is not always the same? List the amount that you normally receive. For example, if you normally make \$1,000 each month, but you missed some work last month and only made \$900, put down that you made \$1000 per month. If you normally get overtime, include it, but do not include it if you only work overtime sometimes. If you have lost a job or had your hours or wages reduced, use your current income.
- 12. What if some household members have no income to report? Household members may not receive some types of income we ask you to report on the application, or may not receive income at all. When this happens, please write "0" in the field. However, if any income fields are left empty or blank, those will also be counted as zeroes. Please be careful when leaving income fields blank, as we will assume you meant to do so.
- 13. We are in the military. Do we report our income differently? Your basic pay and cash bonuses must be reported as income. If you get any cash value allowances for off-base housing, food or clothing, or receive Family Subsistence Supplemental Allowance payments, these must also be included as income. However, if your housing is part of the Military Housing Privatization Initiative, do not include your housing allowance as income. Any additional combat pay resulting from deployment is also excluded from income.

- 14. What if there isn't enough space on the application for my family? List any additional household members on a separate piece of paper and attach to your application. Contact Colleen DeClerck, 860.425.5521 or your child's house office to receive a second application.
- 15. **My family needs more help. Are there other programs we might apply for?** To find out how to apply for SNAP benefits and to contact the Department of Social Services office in your town, contact United Way's free referral number **2-1-1** (free call, statewide).

How to Apply for Free and Reduced-price School Meals

Please use these instructions to help you fill out the application for free or reduced-price school meals. You are required to complete an application for students attending Norwich Free Academy. If siblings attend elementary school or school in a partner district, you are required to complete an application for that district as well. The application must be filled out completely to certify your children for free or reduced-price school meals. Please follow these instructions in order! Each step of the instructions is the same as the steps on the application. If at any time you are not sure what to do next, please contact Colleen DeClerck, 860.425.5521 or declerckc@nfaschool.org

PLEASE USE A PEN (NOT A PENCIL) WHEN FILLING OUT THE APPLICATION AND DO YOUR BEST TO PRINT CLEARLY.

Step 1: List all household members who are infants, children, and students up to and including grade 12

Tell us how many infants, children, and school students live in your household. They do NOT have to be related to you to be a part of your household.

Who should I list here? When filling out this section, please include ALL members in your household who are:

- Children age 18 or under AND are supported with the household's income;
- In your care under a foster arrangement, or qualify as homeless or runaway youth;
- Students attending **Norwich Free Academy**, regardless of age.

A) List each child's name. Print each child's name. Use one line of the application for each child. When printing names, please print clearly. If there are more children present than lines on the application, attach a second piece of paper with all required information for the additional children.

B) Is the child a student in the district? List the name of the school, the grade and mark "Yes" or "No" under the column titled "Student" to tell us which children attend school in the district. If you marked "Yes," write the grade level of the student in the "Grade" column.

C) Do you have any foster children? If any children listed are foster children, mark the "Foster Child" box next to the child's name. If you are ONLY applying for foster children, after finishing STEP 1, go to STEP 4. Foster children who live with you may count as members of your household and should be listed on your application. If you are applying for both foster and nonfoster children, go to step 3.

D) Are any children homeless, runaway or in a Head Start Program? If you believe any child listed in this section meets this description, mark the "Head Start or Homeless/Runaway" box next to the child's name and complete all steps of the application.

Step 2: Do any household members currently participate in SNAP or TFA?

If anyone in your household (including you) currently participates in one or more of the assistance programs listed below, your children are eligible for free school meals:

- The Supplemental Nutrition Assistance Program (SNAP)
- Temporary Family Assistance (TFA)

A) If no one in your household participates in any of the above listed programs:

• Leave STEP 2 blank and go to STEP 3.

B) If anyone in your household participates in any of the above listed programs:

• Write a case number for SNAP or TFA. You only need to provide one case number. If you participate in one of these programs and do not know your case number, contact your DSS social worker.

Note: Do not use a HUSKY Medical Benefits number since this number is not a SNAP or TFA case number. It is also recommended (but not required) that you submit proof of this SNAP or TFA case number when you submit the application for processing. Proof does NOT include a copy of the CONNECT card.

• Go to STEP 4.

Step 3: Report income for all household members

How do I report my income?

- Use the charts titled "Sources of Income for Children" and "Sources of Income for Adult," printed on the back side of the application form, to determine if your household has income to report.
- Report all amounts in GROSS INCOME ONLY. Report all income in whole dollars. Do not include cents.
 - o Gross income is the total income received before taxes.
 - o Many people think of income as the amount they "take home" and not the total "gross" amount. Make sure that the income you report on this application has NOT been reduced to pay for taxes, insurance premiums, or any other amounts taken from your pay.
- Write a "0" in any fields where there is no income to report. Any income fields left empty or blank will also be counted as a zero. If you write '0' or leave any fields blank, you are certifying (promising) that there is no income to report. If local officials suspect that your household income was reported incorrectly, your application will be investigated.
- Mark how often each type of income is received using the check boxes to the right of each field.

3.A. Report income earned by children

A) Report all income earned or received by children. Report the combined gross income for ALL children listed in STEP 1 in your household in the box marked "Child Income." Only count foster children's income if you are applying for them together with the rest of your household.

What is Child Income? Child income is money received from outside your household that is paid DIRECTLY to your children. Many households do not have any child income.

3.B. Report income earned by adults

E) Report income from

- When filling out this section, please include ALL adult members in your household who are living with you and share income and expenses, even if they are not related and even if they do not receive income of their own.
- Do NOT include:
 - o People who live with you but are not supported by your household's income AND do not contribute income to your household.
 - o Infants, children and students already listed in STEP 1.
- B) List adult household members' names. Print the name of each household member in the boxes marked "Names of Adult Household Members (First and Last)." Do not list any household members you listed in STEP 1. If a child listed in STEP 1 has income, follow the instructions in STEP 3, part A.

- **C)** Report earnings from work. Report all income from work in the "Earnings from Work" field on the application. This is usually the money received from working at jobs. If you are a self-employed business or farm owner, you will report your net income.
- **What if I am self-employed?** Report income from that work as a net amount. This is calculated by subtracting the total operating expenses of your business from its gross receipts or revenue.

Is your child protected by health insurance? If not, your school and the State of Connecticut want to help.

Connecticut's HUSKY Health program, for example, pays for doctor visits (including physical exams), prescriptions, emergency care, vision and dental care, mental healthcare, special healthcare needs and more. It's for children under age 19 in families of all incomes. Approximately 300,000 Connecticut children now have their healthcare covered by the HUSKY Health program. There are two parts to the HUSKY Health program for children:

- I. **HUSKY A** (or Medicaid) For children in families with limited income. Parents, relative caregivers and pregnant women may also be eligible.
- II. HUSKY B (or Children's Health Insurance Program) For children in families with higher incomes.

You can apply for HUSKY A or HUSKY B any time of the year.

Addendum C: Information on the Supplemental Nutrition Assistance Program (SNAP)

Dear Parent/Guardian:

If your children qualify for free school meals or milk, you might also qualify for **SNAP** (formerly called Food Stamps). SNAP helps people buy food for themselves and their families. SNAP benefits are issued each month on plastic debit cards. You can use SNAP benefits to buy food at major supermarkets, neighborhood grocery stores, and some farmers' markets authorized to accept SNAP.

How to Qualify

If and how much SNAP you qualify for depends on: your household's income;

- allowable deductions to your household's income (examples include monthly shelter expenses, medical bills, and court ordered child support);
- your household size; and
- at least 5 years U.S. residency for qualified noncitizens.

If you have access to the Internet, you can go online to see if you may be eligible for SNAP. Go to www.connect.ct.gov and click "Am I Eligible?" Owning your own home or owning a car will not prevent you from being eligible for SNAP.
