

La Porte ISD Meal Pickup During Virtual Learning

During the virtual learning portion of our instructional year (August 19th through September 4th), the LPISD School Nutrition Department will be offering curbside meal service to all enrolled students.

- Meals will be available every instructional day from 11am to 1pm at each school.
- You must pick up your meals at the school where your student is enrolled.
- You will receive a lunch for that day and a breakfast for the following morning.
- The parent/guardian may pick up meals without the student present in the vehicle, but the parent/guardian will need to provide one of the following for each student not present:

Student ID number, student ID badge, or an official document from the campus listing the student as enrolled.

The meals are not free for all students. Meals will be charged based on the student's status of free, reduced or full-paid. We will be able to accept checks and cash, but our abilities to make change will be limited. With that in mind, we highly encourage you to utilize www.myschoolbucks.com to place funds on your student's meal account. Meal prices are as follows:

PK-12th Grade Reduced Breakfast:	\$.30
PK-12th Grade Paid Breakfast:	\$1.25
PK-12th Grade Reduced Lunch:	\$.40
PK-8th Grade Paid Lunch:	\$2.25
9-12th Grade Paid Lunch:	\$2.50

La Porte ISD is now accepting free and reduced meal applications. All 2019-20 school meal applications will expire on September 30, 2020. To continue to qualify for meal benefits, you must submit a new meal application as soon as possible. You may complete an application on-line by going to www.nlappscloud.com or request a printed copy from your school.

If you have already received a letter from the Nutrition Office stating your meal benefits for 2020-21, please do not submit a new application, but please contact the Nutrition Office if the information on the letter is incorrect. Please call the Nutrition Office at 281-604-6950 for additional information or visit our office located at 2015 Sens Road in the Support Services Center.

The **Richard B. Russell National School Lunch Act** requires the information on this application. You do not have to give the information, but if you do not, we cannot approve your child for free or reduced price meals. You must include the last four digits of the social security number of the adult household member who signs the application. The last four digits of the social security number is not required when you apply on behalf of a foster child or you list a Supplemental Nutrition Assistance Program (SNAP), Temporary Assistance for Needy Families (TANF) Program or Food Distribution Program on Indian Reservations (FDPIR) case number or other FDPIR identifier for your child or when you indicate that the adult household member signing the application does not have a social security number. We will use your information to determine if your child is eligible for free or reduced price meals, and for administration and enforcement of the lunch and breakfast programs. We MAY share your eligibility information with education, health, and nutrition programs to help them evaluate, fund, or determine benefits for their programs, auditors for program reviews, and law enforcement officials to help them look into violations of program rules. In accordance with Federal civil rights law and U.S. Department of Agriculture (USDA) civil rights regulations and policies, the USDA, its Agencies, offices, and employees, and institutions participating in or administering USDA programs are prohibited from discriminating based on race, color, national origin, sex, disability, age, or reprisal or retaliation for prior civil rights activity in any program or activity conducted or funded by USDA. Persons with disabilities who require alternative means of communication for program information (e.g. Braille, large print, audiotape, American Sign Language, etc.), should contact the Agency (State or local) where they applied for benefits. Individuals who are deaf, hard of hearing or have speech disabilities may contact USDA through the Federal Relay Service at (800) 877-8339. Additionally, program information may be made available in languages other than English.
