



## OPERATIONAL BLUEPRINT FOR SCHOOL REENTRY 2020-21

As the year progresses, the PA will open for onsite opportunities for students. This will primarily involve small groups of students. Opening will follow the access requirements for small groups as dictated by the **Ready Schools, Safe Learners** guidance.

The Philomath Academy, a new school this year, will offer only online opportunities for students throughout the school year. One component of the Philomath Academy is designed to support students and families seeking a fully online experience for learning. As we experience the range of COVID-19 decisions, a number of our families do not wish to return their children to a brick-and-mortar school. For these students and families, the Philomath Academy will immediately be available.

As the school year progresses, the Academy will open for small group opportunities for students seeking credit recovery as well as students seeking an alternative path for K-12 schooling. Students involved in these groups will experience a combination of online and in-person opportunities.

On Monday, September 28, 2020, the Philomath Academy will decide on possible readiness to initiate Hybrid Learning. By that time, the completed Blueprint will be submit to ODE for approval.
