- Our 48 member schools have founding dates ranging from 1829 to 2002.
- We advocate for quality independent school education for 27,000 students and offer collaboration opportunities for over 4000 staff.
- CIS Ontario was incorporated in 1983, replacing and building upon two more informal networks of
 independent schools, with a new association designed to serve twenty-three member schools
 within the province.
- We are closely affiliated with the <u>Canadian Accredited Independent Schools</u>, the national association that accredits the majority of our schools. We are also members of the <u>National Association of Independent Schools</u> (U.S.), the Independent Schools Association Network (U.S.). In addition, we liaise with the <u>Ontario Ministry of Education</u> and <u>The Ontario College of Teachers</u> on behalf of our member schools.

The Conference of Independent Schools of Ontario (CIS Ontario), is a one-stop network for supporting leadership and excellence in independent school education.

- + Faculty and staff members at our 48 affiliate schools find inspiration and information at our <u>professional-learning</u> opportunities.
- + We offer an extraordinary range of student programs. More than 1,400 students province-wide benefit from the <u>music</u>, <u>drama</u>, <u>visual arts</u> and <u>dance</u> festivals we provide annually to our girls', boys' and co-ed member schools. There are also additional enrichment events for our students such as <u>Thrive Student Leaders</u> and <u>Future Prize for Middle School students</u>.
- + On the athletics front, more than 1,400 sports teams operate within the <u>Conference of</u> Independent Schools of Ontario Athletics Association (CISAA), far above the provincial average.
