# Farmington High Policy regarding clubs and organizations

## Section I: Clubs

A. School Sponsored Club - Any club that will receive an assigned advisor that is directly related to the academic offerings of the school. Only school sponsored clubs may do announcements over the school P.A. and post information in the building regarding club related events.

B. Student Sponsored Club - Any club that is organized and run by students based on student interests that do not violate Davis School District policies or guidelines.

## Section II: Applications for Clubs

A. Any group of Farmington High School Students desiring to organize a club for a specific purpose or activity MUST meet all of the Davis School District Policy 4I-412 as found in the Davis School District Policy Manual. The proposed club/organization must make an application to the Student Government Executive Board (SGEB) on the appropriate club application forms.

The application for club acceptance will include but is not limited to the following:

1. The club/organization's stated purposes
2. A club president or a responsible person for communication purposes
3. A petition of a minimum of 10 signatures of proposed members. Students must be currently enrolled students of Farmington High. A club will remain viable if it maintains an active membership of ten. When membership falls below ten the charter will be revoked.
4. Club Advisor's name. All advisors must meet the following criteria;
  - (a) The advisor must be a Certified Faculty member of Farmington High and must be in attendance to all club activities and meetings.
  - (b) Faculty members may only sponsor or advise one club in any given school year.
  - (c) A statement concerning time, frequency of and location of club meetings.
5. Application deadline is September 28<sup>th</sup>. Any application submitted after this date will not be considered for approval for the current school year.
6. All applications will be reviewed for approval by the FHS Administration and the SGEB. No member of the SGEB is eligible to hold office in any other club or organization.

\*\*All students must have parental permission to be in a club. Please fill out the following permission slip with your club information BEFORE you make copies for your students.
