UHS STUDENT PARKING UPDATE

Good Morning,

As you know, the school district has moved to a 100% remote plan to start the school year.

Please note the following updates regarding student parking:

1. Our original parking plan, based on the hybrid model announced earlier in August, may change based on how students return to school in October. Depending on the plan, parking availability may be different from the original plan. Please know that **NO DECISIONS HAVE BEEN MADE**, but we want to alert you that the original student parking plan may change.
2. We will continue to accept electronic parking registrations through the UHS website. Submitting an application may not guarantee a parking spot for sophomores or juniors. Again, it will depend on our reopening plan in October.
3. The student parking fee may be adjusted from the price (\$33) listed in the form.

We appreciate your flexibility and understanding as we start the 2020-2021 school year. As new information becomes available, we will provide you with parking updates.

UNIONVILLE HS- FALL 2020 PARKING INSTRUCTIONS

Given our current instructional plan we have modified student parking procedures for the start of the school year. While we are in the hybrid model, our goal is to provide parking to all eligible student drivers on their assigned school days for the first semester.

Please read through these general instructions before completing your parking pass application.

GENERAL PARKING INFORMATION

1. At this time we are only assigning parking for the first semester.
2. All eligible drivers in grades 10, 11, and 12 can apply for first semester parking.
3. Students will only receive parking for the letter days that they attend school in person (A/B, C/D, or E/F).
4. All students must currently have a license to apply for parking. Students who receive a license later in the fall can apply for parking when they receive their license.
5. We will monitor the student parking situation throughout the semester. ***Please note that changes to our school attendance plan may have a negative impact on student parking.***
6. We will provide information about parking for the second semester later in the fall.

PARKING APPLICATION INSTRUCTIONS

1. **Please make the time to complete the application in one sitting. You WILL NOT be able to save a partial application and return to finish it.**
2. **GATHER ALL INFORMATION AHEAD OF TIME.** Please make sure that you have scans/ pictures of your license, valid vehicle registration, and valid insurance card. You will be asked to upload them as a part of the application. You will also need to enter your driver's license number, the make and model of your vehicle(s) and the name of your insurance company and policy number.
3. Please make sure that you have a parent/ guardian who can sign off on the parking regulations at the end of the application.
4. Don't forget to hit "SUBMIT" at the end of the application.
5. Please use the application that matches your grade.
