MARKET RECAP - AUGUST 2019:

The month of August was marked by a major escalation of the U.S./China trade war, volatility in financial markets, and plummeting bond yields. Trade war hostilities began on the first day of the month with President Trump announcing 10% tariffs on another \$300 billion of Chinese goods, bringing the total amount of Chinese imports covered by tariffs to 90%. China would fire back days later by instructing state-owned companies to cease all purchases of U.S. farm products and allowing its currency to fall to its weakest level since December. The next day the U.S. Treasury designated China a currency manipulator. Attention briefly shifted to the Fed's annual symposium in Jackson Hole, Wyoming where a parade of interviews with Fed officials offered varying opinions on the economic outlook and the need for rate cuts. Chair Powell's highly anticipated speech was well balanced but failed to provide the clarity investors hoped for. His speech was also overshadowed when earlier that same day China announced it would place additional tariffs on \$75 billion of U.S. imports, including tariffs as high as 50% on some U.S. cars and trucks. President Trump, who has been badgering the Fed to cut the overnight rate as much as 100 basis points, responded angrily in a series of tweets, including, "...my only question is who is our bigger enemy, Jay Powell or Chairman Xi?" Later that afternoon he would retaliate against China by announcing another round of sharp increases in tariffs. As the month drew to a close, a spokesman for China's Ministry of Commerce extended an olive branch, saying, "China has ample means for retaliation, but thinks the question that should be asked now is about removing new tariffs to prevent escalation of the trade war."

Economic data followed the path that has developed in recent months, with resilient backward looking data and deteriorating forward looking data. Non-farm payrolls held close to forecast with +164k new jobs in July and a steady 3.7% unemployment rate. Consumer spending was surprisingly strong as retail sales more than doubled the Bloomberg survey estimate with a +0.7% July increase. Retail sales over the last three months are up +3.3% versus the same period last year. Inflation readings have firmed up as well, with core CPI running at a +2.2% year-over-year pace. The manufacturing sector has borne the brunt of the trade war's impact to date as indicated by a fifth straight decline in the ISM manufacturing index which has dropped from over 60 a year ago to 51.2 in July. This forward looking survey sits just above the 50 mark that divides expansion from contraction. The global manufacturing sector is also slumping and the growing concern is it will drag the consumer and the rest of the economy down with it.

Stocks endured an extremely volatile month. Of the 22 trading days in August, 15 saw intraday moves greater than 300 points on the Dow while the trading range from high to low spanned more than 1800 points or nearly 7%. In the end, both the Dow and the S&P 500 finished the month down about -1.8% while the Nasdaq lost -2.6%. Bond yields plummeted as the trade war took its toll on the outlook. The yield on the 10-year Treasury note plunged more than 50 basis points to 1.47%, dipping below the two-year yield, officially inverting the curve and sparking debate about whether this signaled a looming recession. Despite those declines, bond yields in the U.S. remain the highest of the major economic powers, suggesting they could have further to fall.

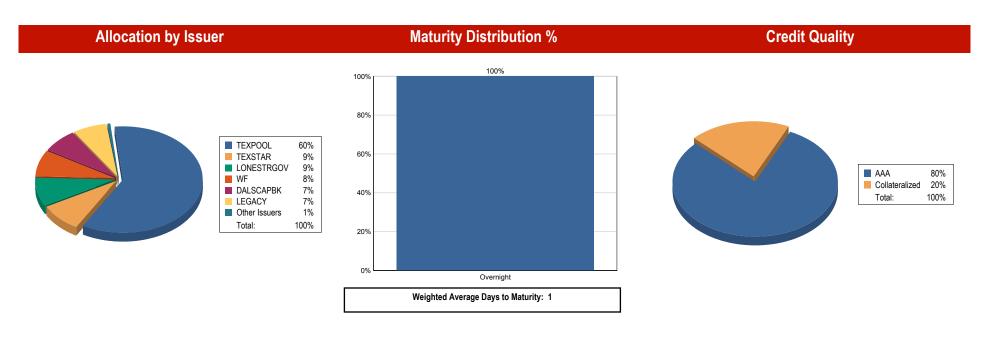

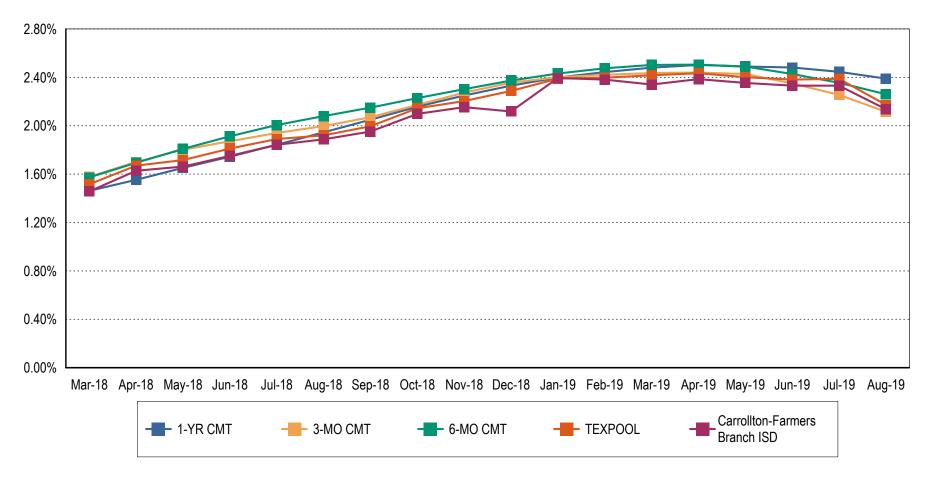
