**July 2020**

**Revenues**

- The district did not receive property taxes during the month of July. The breakdown of our 19-20 tax levies has been attached for your review (page 15).
- The district received a \$17,625 WASBO purchase card rebate check during the month of July.

**Expenses**

- Object 249 reflects the set up of HRA accounts for staff participating in the district's health insurance benefit.
- Object 324 reflects annual service agreements for HVAC chillers and boilers, elevators, and the district mailing machine.
- Object 362 includes STAR math and reading online assessments, annual licensing for Dreambox, Akitabox, ISCorp, Educlimber, Shoutpoint Messaging, VMax, and online access to Alice training.
- Object 470 purchases include High School AP Psychology, U.S. Government, Economics, and Music Theory textbooks.
